You have the right to file a complaint with our agency. The OSBMLS has jurisdiction over the following professionals:

Please provide as much detail as possible as our decision for further action will be based on the facts as presented in your complaint.

You will receive acknowledgment of our receipt of your complaint. Your complaint will then be reviewed by the Medical Director and/or Executive Director for possible violations of the Oklahoma Medical Practice Act and the Board's rules and regulations.

Should you change addresses before your complaint is resolved, please notify this office so we may contact you with the results of any review, investigation or disciplinary hearing.

This agency is an administrative licensing agency and has no jurisdiction over persons not holding one of our professional licenses. If you feel someone is practicing without a license, you should contact the District Attorney's office in that county for criminal prosecution.
