On 06/10/2011, members of the Kissimmee Police Department's Criminal Investigations Division conducted an undercover operation targeting prostitution advertisements from an Internet site called Backpage.com. The undercover operation was conducted at [REDACTED], Kissimmee, Florida.

In order to curtail this type of crime and other crimes associated with prostitution, an advertisement was placed on backpage.com (advertisement # 4722856) to solicit persons looking to pay for sexual acts. At approximately 1556 hours, Detective Heinz received a call from a male, later identified as Ramarao Makkena, who asked where we were located and asked to confirm the \$100 price for a Hispanic female. Makkena asked for directions from Kissimmee and stated he was on his way.

At approximately 1616 hours, Makkena called back and stated he was at the gate of [REDACTED]. A short time later, Makkena arrived at [REDACTED] in a 2011 white Subaru Outback, bearing Florida license plate D474IU. Makkena exited his vehicle, walked up to the front door, and knocked. Captain W. Shepard met Makkena at the front door. Captain W. Shepard asked Makkena if he had come to the location for the white female or the Mexican female (referring to advertisements we had posted on backpage.com on 6/9/11). Makkena stated he wanted to look first. Captain W. Shepard stated it was \$100.00 for an hour of straight sex. Captain W. Shepard stated no greek or anal (both terms are used to refer to anal sex) and Makkena had to wear a condom because there was no fluid exchange. Captain W. Shepard again stated the price was \$100.00 and Makkena handed Captain W. Shepard cash. Captain W. Shepard asked if Makkena had a condom with him. Makkena stated he had one in the car but asked to use one supplied by Captain W. Shepard. Makkena entered the residence, which is in direct violation of violation of F.S.S. 796.07(2)(C), Assignment of Prostitution and F.S.S. 796.07(2)(G) and Entering a dwelling for Prostitution. After Makkena entered the residence, he was taken into custody.

A search of Makkena's cellular phone showed the Kissimmee Police Department's undercover cell phone number as his last phone number called. The advertisement that was posted on backpage.com, the recorded telephone conversation, and the money Makkena handed to Captain W. Shepard were later submitted as evidence at the Kissimmee Police Department.

Felds was summoned to tow Makkena vehicle. Prior to being towed, the vehicle was inventoried.

In conclusion, the Kissimmee Police Department conducted an undercover operation, targeting individuals that use backpage.com to solicit and pay others for sex. Makkena contacted Captain W. Shepard and agreed to pay \$100.00 for straight vaginal sex, which is in violation of F.S.S. 796.07(2)(e), Assignment of Prostitution. Makkena then proceeded to [REDACTED] and entered the residence, to

engage in sexual activity with Detective Heinz, who Makkena believed to be a prostitute, which is in violation of F.S.S. 796.07(2)(g), Entering a Dwelling for Prostitution.

Makkena was placed under arrest and transported to the Osceola County Jail where he/she was held on a \$500.00 bond.

This case was cleared by arrest and forwarded to the State Attorney's Office.
