On 10/21/06 at 1507, Officer T.L.Jackson (6305) and I responded to 4020 La Vista Cir. #201 (Villages of San Jose) in reference to a domestic battery. Upon arrival, the Victim (Ms. Shukla) met us at the front door. Her nose and mouth was covered in fresh blood.

She stated that her husband (Suspect Montero) had been drinking. She went into the room where he was and told him that he was not supposed to be drinking since he had just gotten out of Detox. She then went into the bedroom. The Suspect followed her into the bedroom and confronted her. He was carrying a dumbbell in his hand and was getting close to her as they argued. She became afraid of him because he was charged with aggravated domestic assault in a previous incident for swinging a dumbbell at her during an argument. Because of this history, she became afraid when he got close to her while carrying the dumbbell and pushed him away. The Suspect then hit her in the nose. She was unsure if he hit her with a fist or an open hand and was unsure which hand he used since it happened so quickly. After hitting her, he laid her on the bed and sat on her to calm her down. During the struggle with her husband, she scratched him and bit him on his right arm. Suspect Montero eventually left the room and she called 911.

I observed fresh blood on the bed, phone, nightstand, and floor in the bedroom and bathroom. There was also a bloody wash cloth in the bathroom that was wet. Both of the bathroom sinks had what appeared to be watered down blood in them as if someone was trying to rinse out the cloth.

I spoke with Suspect Montero about the incident after Mirandizing him via card. Post miranda, he stated that he had been drinking and that his wife (the Victim) came to where he was and started arguing with him about his drinking. He stated that she must have hit herself because he did not hit her. He stated that he did not see her hit herself though. He advised that she became upset during the argument and scratched his right arm. She then bit his arm. He left the room and she told him that she was going to get him this time. She then called the police.

I observed some small scratches to the Suspect's right arm and a small bloody spot where he said the Victim had bitten him.

The Victim and Suspect have been married for 22 years.

The Suspect was taken into custody without incident, handcuffed and transported to the P.D.F.

An E.T. was called to photograph the Victim's injuries and all of the blood in the bedroom and bathroom.

The Victim was given the required Domestic Violence paperwork.

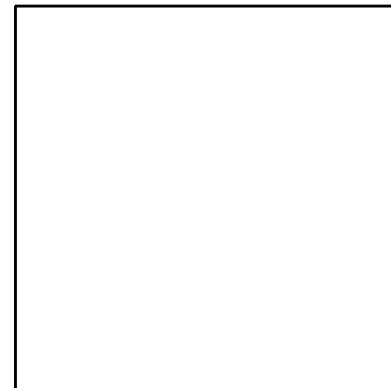
