VOLUNTARY SURRENDER OF LICENSE



I, Marc D. Pellicciaro, M.D., voluntarily surrender my Alaska license #S4850, which was first issued to me on July 17, 2002, and has an expiration date of December 31, 2008.

I am surrendering my above physician's license at this time with the understanding that the Division of Corporations, Business and Professional Licensing is conducting an active investigation under case number 2800 09 004 on behalf of the Alaska State Medical Board (Board), concerning allegations of practicing medicine with a lapsed license. I understand that should I reapply for licensure in Alaska, the Board may impose disciplinary action pertaining to my practice of medicine with a lapsed license before my license is reinstated.

I understand that as a result of this surrender, I can not practice as physician in the State of Alaska, and will not be able to do so until I have the approval of the Board. I further understand that before my certificate to practice as a physician in Alaska can be reinstated, I will have to prove to the above Board that I am competent to resume practice, and am able to do so with skill and safety. If I make such request for reinstatement, and I am denied by the Board, I have the right to a Hearing, pursuant to AS 44.62, of the Administrative Procedure Act.

I am surrendering my license of my own free will. I am not under the influence of any medicine or other drugs that would affect my ability to think clearly and rationally. No promises or threats have been made to me by anyone to make me sign this document.
