ORDER

This matter is before the Alabama State Board of Medical Examiners based upon the January 5, 1990 Order to Show Cause which was entered pursuant to the request of William Jerry Howell, M.D. for an unrestricted Alabama Controlled Substances Registration Certificate. A reinstatement hearing was held on February 21, 1990. Dr. Howell, who declined representation by counsel, was present at the hearing and presented sworn testimony to the Alabama State Board of Medical Examiners. The Honorable Wendell R. Morgan served as hearing officer, and the Honorable Patricia E. Shaner appeared as counsel for the Board. The Board received into evidence documents and testimony concerning Dr. Howell's qualifications to possess an unrestricted Alabama Controlled Substances Registration Certificate.

After consideration of all the evidence before the Board and based on that evidence, the Board finds that William Jerry Howell, M.D. is qualified to possess an unrestricted Alabama Controlled Substances Registration Certificate and that Dr. Howell's request is due to be granted.

Therefore, it is the ORDER of the Alabama State Board of Medical Examiners that William Jerry Howell, M.D., be issued a full unrestricted 1990 Alabama Controlled Substances Registration Certificate.

ORDER

This matter is before the Alabama State Board of Medical Examiners based upon the October 24, 1986, Order To Show Cause which was entered due to the request of William Jerry Howell, M.D., for an unrestricted Alabama Controlled Substances Registration Certificate. A reinstatement hearing was held on December 17, 1986. Dr. Howell, who declined representation by counsel, was present at the hearing and presented sworn testimony to the Alabama Board of Medical Examiners. The Honorable Wendell R. Morgan appeared as counsel for the Board, and the Honorable Patricia E. Shaner served as hearing officer. The Board received into evidence several documents concerning Dr. Howell's qualifications to possess an unrestricted Alabama Controlled Substances Registration Certificate.

After consideration of all the evidence before the Board, the Board finds that William Jerry Howell, M.D., is qualified to possess a full 1987 Alabama Controlled Substances Registration Certificate conditioned on the following restrictions and requirements:

1. That the use by William Jerry Howell, M.D., of Schedule II and Schedule IIN drugs be restricted to hospitals, emergency rooms, and nursing homes only;
2. That William Jerry Howell, M.D., shall authorize Mutual Assurance Society to release to the Alabama Board of Medical Examiners copies of all documents pertaining to William Jerry Howell, M.D., in the possession of Mutual Assurance Society;
3. That William Jerry Howell, M.D., shall submit to the Alabama Board of Medical Examiners copies of the results of all drug screens undergone by him.

Based upon the foregoing, it is the Order of the Alabama Board of Medical Examiners that William Jerry Howell, M.D., be issued a 1987 Alabama Controlled Substances Registration Certificate conditioned on the restrictions and requirements enumerated in paragraphs 1 through 3 above.
