Citation

An administrative citation is hereby issued to you in accordance with Business and Professions Code section 125.9 for violation of section 2234 of the Business and Professions Code - Unprofessional Conduct for the Violation of Section 802.1 of the Business and Professions Code - Failure to Report Misdemeanor Conviction.

License

License A 89189 was issued to you on 27 October 2004 and expires 30 September 2010.

Cause for Citation

You failed to report to the Medical Board, in writing within thirty (30) days, of a misdemeanor conviction dated on or about 27 August 2007 for the plea of nolo contendere to the violation of Section 23152(b) of the Vehicle Code.

Order of Abatement

The Medical Board is ordering you to complete and returned the required "Physician Reporting - Criminal Actions" form to the Board within thirty (30) days from receipt of this citation.

Fine


WITHIN THIRTY (30) DAYS OF RECEIPT OF THIS CITATION, YOU ARE REQUIRED TO PAY AN ADMINISTRATIVE FINE IN THE AMOUNT OF \$750.00 AS PROVIDED BY TITLE 16 OF THE CALIFORNIA CODE OF REGULATIONS SECTIONS 1364.10 AND 1364.11 FOR VIOLATION OF SECTION 2234 OF THE BUSINESS AND PROFESSIONS CODE FOR VIOLATION OF SECTION 802.1.

If you appeal this citation, the days given for compliance will be held in abeyance only for the violation(s) you contest. The time to correct all uncontested violations must be adhered to as given.
