STIPULATION AND ORDER RE INTERIM
RESTRICTION OF PRACTICE

16 Complainant and Respondent agree that the following facts and circumstances exist:

17 Complainant has conducted an investigation and is prepared to file an Accusation based on said
18 investigation; Complainant has filed a Petition for Interim Suspension requesting an interim
19 restriction of Respondent's license; Respondent desires to satisfy Complainant that the public will
20 not be at risk by his continued medical practice pending an evidentiary hearing on such
21 Accusation as Complainant may file.


23 Wherefore, Complainant and Respondent stipulate and agree:

24 1. Respondent's Physician's and Surgeon's Certificate No. G80122 shall be restricted
25 on an interim basis and Respondent shall have a female third party chaperone present while
26 consulting, examining or treating female patients.

- 1 2. Within five (5) business days of the entry of order on this stipulation, Respondent
2 shall submit to the Office of the Attorney General for the Board's prior approval the name(s) of
3 persons who will act as the third party chaperone.
- 4 3. Each third party chaperone shall be provided with a copy of this stipulation and order.
- 5 4. Each third party chaperone shall sign (in ink or electronically) and date each patient
6 medical record at the time the chaperone's services are provided.
- 7 5. Respondent shall maintain a log of all patients seen for whom a third party chaperone
8 is required. The log shall contain the: 1) patient's initials, address and telephone number;
9 2) medical record number; and 3) date of service. Respondent shall keep this log in a separate file
10 or ledger, in chronological order, shall make the log available for immediate inspection and
11 copying on the premises at all times during business hours by the Board or its designee, shall
12 produce a copy upon request and shall retain the log so long as this stipulation and order is in
13 effect.

- 15 6. If the approved third party chaperone is no longer available, Respondent shall submit
16 for prior approval the name(s) of person(s) who will assume the duties of chaperone within three
17 (3) days. Respondent shall not consult, examine or treat female patients until the proposed
18 chaperone replacement is approved.
- 19 7. Respondent agrees that this stipulation and order restricting his license shall remain in
20 force and effect until such time as a hearing may be held and a decision issued by the Board or,
21 alternatively, until the Board has adopted a stipulated settlement and order in this matter.
- 22 8. Respondent agrees that, pursuant to Business and Professions Code section 11529, an
23 Administrative Law Judge shall enter an order restricting Respondent's license as set forth above
24 and that any violation of said order shall constitute grounds for disciplinary action.




