Citation

An administrative Citation Order is hereby issued to you in accordance with Business and Professions Code section 125.9 for violation of section 1338(c) of Title 16, California Code of Regulations.

License G-84088 was issued to you on 8/15/1997 and expires 11/30/2008.

Cause for Citation

On or about April 3, 2006 you were selected to participate in the Board's annual audit of continuing medical education (CME) based on your certification, under penalty of perjury, of compliance with the CME requirements on your last two license renewal notices. In response to the audit, you failed to provide documentation of completion of the required 100 hours of approved CME for the period between January 1, 2002 through December 31, 2005.


