2. Meet all financial obligations/monthly financial statement
3. Victim Compensation Fee (\$163)
4. VAST Fund (\$163)
5. Genetic Testing Surcharge (\$2.50)
6. Additional Court Fees, if applicable
7. Diversion Program Supervision Fee (\$50/mo)
8. Restitution/ joint and several, if applicable
9. Drug Offender Surcharge, if applicable
10. I will maintain suitable employment and/or pursue employment, education, rehabilitation or vocational training
11. Maintain established residence in Metro area
12. **Minimum 100 hours of Community Service Work**
13. Community Service Work at Justice Services, possible (\$85 if referred)
14. Alcohol and Drug Evaluation (ASUS)
15. No drug use/monitored scans at the defendant's expense; (Confirmation fees and ETG scans are additional)
16. No marijuana use
17. Drug/Alcohol Treatment, as determined
18. **Mental Health evaluation and/or treatment, as determined (psychiatric treatment through Colorado Physician Health Program)**
19. Truthfully answer all questions asked of me by the Diversion Officer
20. Report any contact with police/law enforcement agency within 24 hours
21. Cooperate with Diversion Supervision

- 22. No further criminal violation(s)
- 23. If convicted of a felony, or a qualifying misdemeanor as required in § 18-1.3-204(1.5), C.R.S., I will sign a Waiver of Extradition agreeing to waive all formal proceedings and return to Colorado in the event I am arrested in another state.
- 24. Drive with valid license/insurance
- 25. Remain in Colorado (travel permit to leave state is required)
- 26. Will not possess or use dangerous or deadly weapons
- 27. **No alcohol use – monitored scans at defendant's expense (CPIHP)**
- 28. **Antabuse, as determined**
- 29. **Self-Help support group (AA)**
- 30. **Verify prescriptions**
- 31. **Successfully complete Mental Attitude seminar (both classes)**
