
CONSENT AGREEMENT

A Written Complaint has been filed with the Board of Medical Practice ("Board") alleging that Yvette K. Baker, M.D. ("Dr. Baker"), a licensed medical physician and prescriber of controlled substances in the State of Delaware, has engaged in conduct with constitutes grounds for discipline under 24 *Del.C.* C. 17.

Dr. Baker, the State by the undersigned Deputy Attorney General, and the Board hereby enter into this Consent Agreement without the necessity of an emergency hearing before the Board.

IT IS UNDERSTOOD AND AGREED THAT:

- 1. Dr. Baker is a licensed medical doctor in the State of Delaware. Her medical license, number C1-0006698, was first issued in 2002 and is active. Her controlled substances registration, number MD4124, was first issued in 2002 and is active.
 - 2. Dr. Baker's primary specialty is psychiatry/neurology.
 - 3. Dr. Baker provides long-term pain management for many of her psychiatric patients.
- 4. Dr. Baker does not require pain contracts for patients who are self-pay patients and/or have private insurance.



7. Dr. Baker admits the allegations contained in paragraphs 1 through herein.



- 8. Except for the allegations admitted in paragraphs 1 through 6 herein, Dr. Baker denies the allegations of the State's Complaint.
- 9. Dr. Baker, the State, and the Board agree that Dr. Baker's State and Federal controlled substances registrations are immediately restricted as follows:
- a. Dr. Baker is restricted from prescribing, administering, dispensing and/or distributing all Schedule I, II, and III opiates, opiods, and opium derivatives including their isomers, esters, ethers, salts and salts of isomers, esters, ethers controlled substances as defined by Title 16 Chapter 47 and 21 CFR § 1300 et seq;
- b. Dr. Baker shall fully cooperate with the Director of the Office of Controlled Substances to formalize the restriction of her controlled substances registrations including but not limited to the following:
- (1) Within seven days of the signing of this Consent Agreement, Dr. Baker shall submit her State and Federal registrations to the Director of the Office of Controlled Substances;
- (2) Within seven days of the signing of this Consent Agreement, Dr. Baker shall contact the Director of the Office of Controlled Substances to make arrangements to surrender all Schedule I, II, and III opiates, opiods, and opium derivatives including their isomers, esters, ethers, salts and salts of isomers, esters, ethers controlled substances in her possession or control, if any, to the Director of the Office of Controlled Substances;
- c. The restrictions on Dr. Baker's controlled substances registrations will not be lifted or modified except by order of the Board of Medical Practice.
 - 10. In addition, Dr. Baker agrees to the following terms and conditions:

- a. Dr. Baker will immediately refrain from writing any prescriptions for her office staff;
- b. Dr. Baker will maintain adequate medical records concerning all patient treatment and all medications prescribed, administered, dispensed and/or distributed to patients;
- c. Within ninety days of the date Dr. Baker signs this Consent Agreement, she will have referred all pain management patients to pain management specialists;
 - d. Dr. Baker will keep all patient records adequately secured.
- 11. The State's Complaint for Revocation and Petition for Emergency Hearing for Temporary Suspension is hereby amended to remove the request for emergency action and temporary suspension such that the Complaint will be scheduled for a hearing pursuant to the regular procedures of the Board if the Board accepts this Consent Agreement and enters it as an Order.
- 12. The State's Complaint and Request for Revocation or Suspension of Dr. Baker's State and Federal controlled substances registrations will be dismissed without prejudice if the Board accepts this Consent Agreement and enters it as an Order.
- 13. Dr. Baker acknowledges that she is waiving her rights under 24 *Del.C.* Ch.17 and 29 *Del.C.* Ch. 101 to a hearing before the Board prior to the imposition of disciplinary sanctions.
- 14. Dr. Baker acknowledges that she has carefully read and understands this Consent Agreement, that she is entering into this Consent Agreement freely, knowingly, voluntarily, and after having received or having been afforded the opportunity to receive advice of counsel, and that if the Board accepts this Consent Agreement it will become a public document.
- 15. Dr. Baker further agrees that in the event the Board determines not to accept this Consent Agreement, neither she nor anyone on her behalf will in any way or in any forum

challenge the ability of the Board or any of its members to conduct an evidentiary hearing relating to the allegations in the subject Complaint on the basis of the Board's prior consideration of this proposed Consent Agreement. If the Board does not accept the Consent Agreement, the Agreement and its provisions will not be referred to at the hearing, admitted into evidence, or constitute an admission as to any of the facts alleged in the Complaint.

16. This Consent Agreement shall be effective upon execution by Dr. Baker, the Executive Director of the Board of Medical Practice, and the undersigned Deputy Attorney General for the State upon approval by the Board of Medical Practice.
