

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT

On 01/02/11 at approximately 2312 hours, Cpl. Lang #2215, Cpl. McMillan #2659, Cpl. Wray #2011 and Cpl. Caceres #2367 responded to the area of 14556 Indigo Lakes Circle in reference to a fight in progress. Dispatch advised responding units of a possible weapon being mentioned by the person(s) involved in the fight. The reported person to this incident was an anonymous male.

Upon arrival, Cpl. Lang came into contact with Justin Schaller 07/07/1995 (Victim #2) who stated that his father, James Schaller 11/07/60, had threatened to blow his head off with a firearm as a result of a verbal altercation that had taken place. Justin Schaller stated that his father had held a gun to his friend Zachary Kelenski's head and threatened to kill him for pushing his mother Jamie Kelenski.

At this point due to the allegation being made by Justin Schaller, responding units entered the residence at 14555 Indigo Lakes Circle and secured James Schaller. James Schaller was handcuffed and removed from the residence and secured into Cpl. Lang's vehicle. Schaller was advised of his Miranda warnings by Cpl. Lang and he advised he understood them.

During further investigation Justin Schaller stated that he had snuck out of his house at 14555 Indigo Lakes Circle with his friend Zachary Kelenski 04/22/1996 (Victim #1). When they returned to the residence, Zachary Kelenksi's mother, Jamie Kelenski was present and started to get into verbal altercation with Zachary about getting into the vehicle. Zachary refused to enter the vehicle and Jamie, started to spank Zachary on the buttocks area with a wooden switch. Zachary stated to his mother Jamie, that if she continued he would hit her back. Jamie then hit Zachary again and as a result, Zachary then pushed Jamie. James Schaller observed this taking place and then entered his residence and came back out with a small type black revolver handgun and pointed it at Zachary Kelenski's head and told him "That is assault and battery, get into the car, or I will blow your head off". Justin Schaller then stated he attempted to get in the middle of his father and Zachary Kelenski to prevent his father from shooting Zachary and that is when James Schaller turned towards Justin and threatned to blow his head off also. Justin states that his father never aimed the gun at him but did aim the gun at Zachary's head.

Cpl. Lang then spoke with James Schaller and he stated that he did own several firearms and that he does have a small type black revolver that he carries on him at all times. Cpl. Hammond recovered 2 revolver type handguns from the master bedroom area of the residence. James Schaller advised there there was another firearm in the upstairs master bedroom closet and that it should be a Springfield XD. Cpl. Hammond and retrieved that firearm as well.

Det. Tayar was contacted and responded and spoke with Zachary Kelenski and Jamie Kelenski both provided similar statements in reference to the incident. Zachary Kelenski stated that he was in fear for his life at the time that James Schaller pointed the gun at his head and threatened to blow his head off.
