Pursuant to Section 456.077 F.S., the undersigned hereby certifies that he/she has probable cause to believe that on January 19, 2005, the above referenced subject did violate the following provision(s) of law s. 458.331(1)(g)(nn), F.S., by committing the following act(s): **completing the one-hour of domestic violence CME on February 28, 2005, outside of the specified six-month time frame (the deadline was January 19, 2005), and failing to provide proof of completion of two-hours in Prevention of Medical Errors CME and three-hours of AMA approved HIV/AIDS CME.**
