Pursuant to Section 456.077 F.S., the undersigned hereby certifies that he/she has probable cause to believe that on December 6, 2005, the above referenced subject did violate the following provision(s) of law Section 456.072(1)(f)(cc)F.S., pursuant to Section 458.331 (1)(kk) F.S., by committing the following act(s): **Failure to notify the Board in writing within 30 days if action has been taken against one's license to practice medicine in another state, territory, or county based on an action taken by the Florida Board of Medicine.**


