Pursuant to Section 456.077 F.S., the undersigned hereby certifies that he/she has probable cause to believe that on December 2, 2006, the above referenced subject did violate the following provision(s) of law s. 458.331(1)(g)(nn), F.S., by committing the following act(s): **Completing the 2-hours in the Prevention of Medical Errors CME outside the timeframe for the CME Audit period of February 1, 2005 through January 31, 2007.**

Pursuant to Rule 64B8-8.017(3)(a)3, Florida Administrative Code, the Board/Department has set the following penalty for violation of the aforesaid provision: \$250.00 fine plus costs in the amount of \$89.00; within twelve months of the date the citation is issued, Respondent must submit certified documentation of completion of 2-hours of Medical Errors CME; and prior to renewing the license for the next biennium, Respondent must document compliance with the CME requirements for the relevant period.


