Pursuant to Rule 64B8-8.017 Florida Administrative Code, the Board/Department has set the following penalty for violation of the aforesaid provision: within 60 days of the date the citation is issued respondent must submit certified documentation of completion of all the CME requirements for the period for which the citation was issued. Respondent's continuing education courses will be audited for the next two biennia to ensure compliance with renewal requirements AND fine of \$50.00 (\$50 per each hour missing or late) plus costs in the amount of \$122.00.
