SAFETY MANAGEMENT STEPS TAKEN BY INSURED TO MAKE SIMILAR OCCURRENCES LESS LIKELY: Dr. Jimenez was counseled by psychiatric expert as to better documentation in the medical records of his clinical impression of the patient throughout the progress of the psychotherapy, the planned form of treatment and the progress or response to this treatment. It was felt that the lack of documentation weakened his defense of any potential lawsuit stemming from his treatment of this patient, and for this reason, a nominal settlement was decided upon.
