Comes now Ronald V. Saf, Executive Director of the Iowa State Board of Medical Examiners and files this Complaint and Statement of Charges against David B. Weinstein, D.O., a physician licensed pursuant to Chapter 147, Code of Iowa and alleges:

1. That Norman L. Pawlewski is the duly appointed, qualified and acting Commissioner of Public Health of the State of Iowa.

2. That John M. Rhodes, M.D., Chairman; Kenneth R. Carrell, D.O., Vice-Chairman; Rosalie B. Neligh, M.D., Secretary; Cyrus L. Beye, M.D.; Alexander Ervanian, M.D.; Fredrick V. Hetzler, D.O.; Reid E. Motley, M.D.; Joseph A. McCaffrey, Ph.D.; and Mrs. Mary P. Tokheim are the duly appointed, qualified and acting officers and members of the Iowa Board of Medical Examiners.

3. That the respondent is a resident of Honeoye Falls, New York, and was issued license number 1342 to practice osteopathic medicine and surgery in the State of Iowa on the 9th day of July, 1968 as recorded on page 78 in book A of the records of the Iowa State Department of Health.

4. The respondent's license is current until June 30, 1980.

5. That on the 14th day of September, 1977, the Commissioner of Public Health entered an order revoking the respondent's license to practice medicine in Iowa and staying the Order of Revocation and placing the respondent on five year's probation under certain terms and conditions. A copy of the Commissioner's order hereto attached and by the reference made a part hereof.

6. That the respondent has violated paragraph 2 of the Commissioner's order and has not made annual appearances before

the Board as required.

7. That the respondent has violated paragraph 3 of the Commissioner's order. The respondent has furnished no evidence of continuous psychiatric evaluation and treatment.

8. That the respondent has violated paragraph 6 of the Commissioner's order by discontinuance of medical treatment without authorization.


9. That the respondent has violated paragraph 12 of the Commissioner's order by not submitting quarterly reports as required.

10. That the respondent has violated paragraph 15 of the Commissioner's order by not attending Alcoholics Anonymous or a similar organization and providing documentation to the effect that he has conscientiously attended such meetings.

11. That paragraphs 6, 7, 8, 9 and 10 constitute violations of the Commissioner's order entered on the 14th day of September, 1977.

12. That paragraph 16 of the Commissioner's order states that if the respondent violates or fails to comply with any of the terms and conditions of this Order for Probation, the State Board of Medical Examiners, upon receipt of satisfactory evidence thereof, may forthwith terminate said probation, cancel and revoke said stay of execution, and direct that the Order of Revocation herein made shall become effective immediately.

Wherefore the undersigned charges that the respondent, David Benjamin Weinstein, D.O., has violated the terms and conditions of the Commissioner of Public Health's order, which was entered on the 14th day of September, 1977, and further prays that the Board enter an order fixing a time and place of hearing on this Complaint and Statement of Charges and upon final hearing, enter its Findings of Fact and Decision to terminate, cancel and revoke said stay of execution and direct that the Order of Revocation become effective immediately, and for such other and further relief the Board deems just in the premises.
