CONSENT ORDER

THE DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION of the State of Illinois by and through Norman Lasko, attorney, and Petitioner, Robert P. Marseille, M. D. hereby agree to the following:

STIPULATIONS

Petitioner, Robert P. Marseille, M. D. has a Temporary Medical Permit, No. 125.053711 in the State of Illinois currently on Indefinite Probation based on a sister state discipline in the State of Iowa to his Iowa Medical License. On September 9, 2009 the State of Iowa Board of Medicine returned his Iowa medical license to its full privileges, free and clear of all restrictions.

On June 22, 2007, Petitioner entered into a Consent Order placing his application for a Temporary Medical Permit in the State of Illinois on Indefinite Probation requiring compliance with the terms and conditions of the Indefinite Probation in the State of Iowa. Petitioner has provided the required documentation on a quarterly basis to the Probation Unit of the Department of Financial and Professional Regulation of the State of Illinois.

At all times material to the matter set forth in this Consent Order, the Department had jurisdiction over the subject matter and parties herein.

On or about February 24, 2010, the Department received the Petitioner's Petition for Restoration. Petitioner has been in compliance with the terms of the Illinois Probation.

On April 7, 2010, an informal conference was held at the offices of the Department, 100 West Randolph, Chicago, Illinois 60601. Petitioner appeared. Dr. Maria Laporta, M.D. appeared as a member of the Medical Disciplinary Board of the State of Illinois. Norman Lasko appeared on behalf of the Department.

Petitioner has been advised of the right to a hearing on his Petition for Restoration, the right to counsel, and the right to Administrative Review of any Order resulting from a hearing. Petitioner knowingly waives each of these rights, as well as any right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Director or the Medical Disciplinary Board. Petitioner acknowledges that he has freely and willfully entered into this Consent Order without any threat or coercion by any person. Petitioner has not relied upon any representation by or on behalf of the Department other than those set forth herein.

The Petitioner and the Department have agreed, in order to resolve this matter, that Petitioner be allowed to enter into a Consent Order with the Department, providing for the restoration of his Temporary Physician and Surgeon License to active status, which is fair and equitable under the circumstances and consistent with the best interest of the people of the State of Illinois.

CONDITIONS

WHEREFORE, the Department, through Norman Lasko, Attorney, and Petitioner Robert P. Marseille, M. D., D. O., agree:

- A. Petitioner's Temporary Medical Permit, No. 125.053711, shall be restored to Good Standing and the Probation shall be terminated.
- B. This Consent Order shall become effective upon signing and approval by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.
