ORDER

This matter having come before the Director of the Division of Professional Regulation of the Department of Financial and Professional Regulation of the State of Illinois after a Notice of Intent to Refuse to Renew the Illinois Physician and Surgeon License No. 036-069415 of Respondent, Kwan Bo Jin, M.D., was served upon him at his last known email as well as mailed to Respondent via regular mail to his last known mail address with the Department, and Respondent failed to timely file a request for a hearing.

NOW, THEREFORE, I, JESSICA BAER, DIRECTOR OF THE DIVISION OF PROFESSIONAL REGULATION of the Department of Financial and Professional Regulation of the State of Illinois, find:

1. Respondent, Kwan Bo Jin, M.D., is a holder of Illinois Physician and Surgeon License No. 036-069415, which is presently in non-renewed status.
2. Since July 2010, Respondent's Illinois Physician and Surgeon License has been on an Indefinite Probation with multiple conditions which Respondent has violated by failing to submit quarterly reports. See Department's Exhibits 1 and 2, attached hereto and made a part of this Order;

3. Respondent's failure to comply with the terms and conditions of July 2010 Consent Order is grounds for the Department to Refuse to Renew Respondent's Illinois Physician and Surgeon License in violation of Section 60/22(A)(15) of the Illinois Medical Practice Act.

4. I have jurisdiction over the parties and subject matter herein pursuant to 20 ILCS 2105/2105-15 and 225 ILCS 60/22.

IT IS ORDERED that Kwan Bo Jin, M.D., Illinois Physician and Surgeon License No. 036-069415 SHALL NOT BE RENEWED as of the date of this ORDER

SINCE November 1, 2017, Respondent's Illinois Physician and Surgeon License has been placed on non-renewed status. The Department has jurisdiction to investigate complaints and to bring this action pursuant to Illinois Medical Practice Act.

BE NOTIFIED THAT the Department has determined that your license to practice as a Physician and Surgeon in the State of Illinois may be placed on Refuse to Renew status or otherwise disciplined due the following:

- (i) On July 2, 2010, the Director approved the Consent Order Case No. 2008-10918 whereby Respondent was placed on Indefinite Probation for a minimum of two (2) years with multiple conditions. See Department Exhibit 1 attached hereto and made a part of this Notice.
- (ii) Respondent failed to comply with the terms and conditions of July 2010 Consent Order in violation of Section 60.22(A)(15) of the Illinois Medical Practice Act. See Department Exhibit 2, attached hereto and made a part of this Notice.

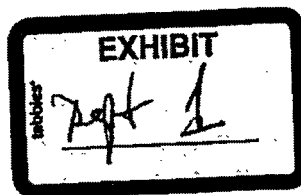
CONSENT ORDER

The Department of Financial and Professional Regulation of the State of Illinois, Division of Professional Regulation, by Lisa Stephens, its Chief of Medical Prosecutions, and Kwan Bo Jin, Respondent, by and through his attorney, Glen D. Crick, hereby agree to the following:

STIPULATIONS

Kwan Bo Jin, M.D. (hereinafter "Respondent") holds a Certificate of Registration as a Physician and Surgeon in the State of Illinois, License No. 036069415, issued by the Department of Financial and Professional Regulation of the State of Illinois. Said license is presently in PROBATION Status. At all times material to the matter set forth in this Consent Order, the Department of Financial and Professional Regulation of the State of Illinois, Division of Professional Regulation (hereinafter the "Department") has had jurisdiction over the subject matter and parties herein.

Information has come to the attention of the Department that on or about September 28, 2009, Respondent pleaded guilty to one count of Health Care Fraud in violation of 18 U.S.C. § 1347, in the United States District Court for the Northern District of Illinois, Case No. 08-CR-



00991. Respondent was sentenced to Probation for a period of two (2) years, the first four (4) months of which, to be served in a work release program. In addition, an Order of Forfeiture was entered against Respondent in the amount of Twenty-Eight Thousand, Three Hundred and Forty-Nine Dollars (\$28, 349.00). Respondent was also ordered to pay Ten Thousand, One Hundred Dollars (\$10,100.00) in fines and assessments.

The allegation(s) as set forth herein, if proven to be true, would constitute grounds for the Department to revoke, suspend, or otherwise discipline Respondent's license to practice as a Physician and Surgeon in the State of Illinois, on the authority of 225 ILCS 60/22(A)(3); and 225 ILCS 60/22(A)(5), relying upon the Rules for the Administration of the Medical Practice Act, 68 Ill. Admin. Code 1285.240(a).

On or about February 11, 2010, the Director of the Department entered a Consent Order (2009 Order) in which Respondent agreed that his Physician and Surgeon License, No. 036069415, would be placed on Suspension for four (4) months to begin retroactively on December 3, 2009, to be followed by Indefinite Probation for a minimum of two (2) years. Respondent agreed to pay the Department a fine in the amount of \$1,000.00 within thirty (30) days of the effective date of the 2009 Order, and as a provision of his Probation, agreed to complete twenty (20) hours of Category I Continuing Medical Education credits within the first six (6) months of the Probation.

Pursuant to the 2009 Order, Respondent's Physician and Surgeon license was placed on Suspension from December 3, 2009 until April 2, 2010. On April 3, 2010, Respondent's license was placed in PROBATION status. Respondent has paid to the Department the \$1,000.00 fine as agreed to in the 2009 Order.

For purposes of this Consent Order only, Respondent acknowledges that should this matter proceed to a contested hearing, the Illinois Medical Disciplinary Board (the "Board")

could find a violation of the Medical Practice Act. The Department and Respondent stipulate that the above acknowledgement is made only for the purposes of this Consent Order. In the event that this Consent Order is not approved by the Board or is not approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Director"), this acknowledgement shall not be admissible in any proceeding and the matter will be set for an evidentiary hearing on the merits as if this Consent Order had not been submitted. In addition, upon approval of this Consent Order, neither this acknowledgement nor this Consent Order may be utilized in any other proceeding, except one to enforce this Agreement.

Respondent has been advised of the right to have pending allegations reduced to written charges, the right to a hearing, the right to contest any charges brought, and the right to administrative review of this Consent Order. Respondent knowingly waives each of these rights, as well as the right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Medical Disciplinary Board or the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

Respondent and the Department have agreed, in order to resolve this matter, that Respondent, Kwan Bo Jin., be permitted to enter into a Consent Order with the Department, providing for the imposition of disciplinary measures which are fair and equitable under the circumstances and which are consistent with the best interests of the people of the State of Illinois.

CONDITIONS

WHEREFORE, the Department, through Lisa Stephens, its Chief of Medical Prosecutions, and Kwan Bo Jin, Respondent, by and through his attorney, Glen D. Crick, hereby agree to the following:

- A. This Consent Order shall supersede the 2009 Order, effective February 11, 2010 (attached hereto as Exhibit A), which placed Respondent's Physician and Surgeon License, No. 036069415 on Suspension for four (4) months to begin retroactively on December 3, 2009, to be followed by Indefinite Probation for a minimum of two (2) years.
- B. Respondent's Physician and Surgeon License, No. 036069415, shall remain on PROBATION for an Indefinite period of not less than two (2) years from the effective date of April 3, 2010.
- C. During the period of PROBATION, Respondent shall adhere to the following:
 1. Respondent shall abide by all the terms and conditions of his Probation ordered by the United States District Court for the Northern District of Illinois on September 28, 2009, in case No. 08-CR-0991 (hereinafter "Court-Ordered Probation"; see exhibit A attached hereto).
 2. Respondent shall successfully complete the 20.5 hour Category I Continuing Medical Education course entitled "Intensive Course in Medical Ethics, Boundaries and Professionalism," offered by Case Western Reserve University School of Medicine, on September 2-3, 2010, as previously approved by the Medical Coordinator of the Department.
 3. During the period of Probation, Respondent shall provide the Department

with quarterly reports which include:

- i. current residential address and contact telephone number;
 - ii. if working as a physician, in a practice other than his own, Respondent shall provide a copy of any performance evaluation completed by his employer within the prior quarter. Respondent, shall at the beginning of Probation, provide the Department with objective documentation as to the frequency of employee performance evaluations;
 - iii. a description of job duties, responsibilities and name of immediate supervisor, if employed in a medical practice other than his own;
 - iv. a copy of all incident reports within the prior quarter if employed in the medical practice other than his own; and
 - v. information, regarding any arrests, criminal, or civil actions filed, including DUI and/or other similar offenses against the Respondent;
4. Respondent shall notify the Department's Chief of Probation Investigations in writing of any change in employment and/or home address and/or telephone number within five (5) days;
 5. If practicing in a solo practice, Respondent shall obtain a Practice Monitor, who is a licensed physician practicing in the State of Illinois in the same specialty as Respondent. The Practice Monitor shall be hired at the expense of Respondent and shall be pre-approved by the Chief Medical Coordinator of the Department. Respondent shall request that his practice monitor

submit quarterly reports about scope, performance appraisals and billing practices.

6. The Practice Monitor shall agree to inform the Department immediately if there is evidence of inappropriate billing practices, professional misconduct, a violation of Respondent's probation or any violation of the laws and rules governing the practice of medicine;
7. Respondent shall immediately notify the Department of any and all complaint(s) against him, including, but not limited to, any allegation of inappropriate billing practices.
8. Respondent shall immediately notify the Department should his relationship with any practice monitor cease and immediately take actions to select a new monitor and obtain the approval of the Chief Medical Coordinator;
9. If Respondent should begin working for another physician, Respondent shall request that his employer shall submit quarterly reports regarding Respondent's performance, evaluations and any and all other issues related to Respondent's work performance;
10. All the reports required to be submitted under the terms of this Probation shall be shall be mailed to:

- D. Respondent agrees that any violation of the terms and conditions of this Consent Order or a violation of the terms of Probation is a violation of 225 ILCS 60/22(A)(15);
- E. Respondent agrees that a violation of this Consent Order permits the Director of the Division of Professional Regulations to issue an Order forthwith mandating the automatic, indefinite and immediate suspension of Respondent's Physician and Surgeon License, No. 036069415, for a minimum period of twelve (12) months. This suspension shall not preclude the Department from taking any other disciplinary or other actions it deems appropriate. In the event Respondent contests in writing (by the filing of an appropriate petition with the Department) the factual basis underlying said suspension within thirty (30) days of the imposition thereof, Respondent shall be afforded a hearing on the merits within thirty (30) days of the filing of said petition.
- F. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

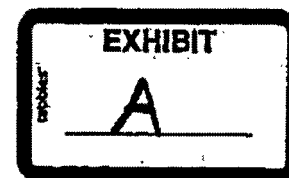

At all times material to the matter set forth in this Consent Order, the Department of Financial and Professional Regulation of the State of Illinois, Division of Professional Regulation (hereinafter the "Department") has had jurisdiction over the subject matter and parties herein.

Information has come to the attention of the Department that on or about September 28, 2009, Respondent pleaded guilty to one count of Health Care Fraud in violation of 18 U.S.C. § 1347, in the United States District Court for the Northern District of Illinois, Case No. 08-CR-00991. Respondent was sentenced to Probation for a period of two (2) years, the first four (4) months of which, to be served in a work release program. In addition, an Order of

WHEREFORE, the Department, through Lisa Stephens, its Chief of Medical Prosecutions, and Kwan Bo Jin, Respondent, agree:

- A. Within the first thirty (30) days after the approval and signing of this Consent Order by the Director, Respondent shall pay to the Department a fine in the amount of One Thousand Dollars (\$1000.00). The fine is to be paid by personal check, cashiers check, or personal money order. Said check shall be made payable to:

This case number, 200810918, shall be reflected in the notation portion of the check.

If Respondent fails to pay the aforementioned fine and the Department initiates a collection effort to retrieve the fine, Respondent shall be responsible for all costs and fees incurred by the Department in said collection effort.

- B. Respondent's Physician and Surgeon License, License No. 036069415 shall be SUSPENDED for a period of four (4) months, to begin retroactively on December 3, 2009, and to run concurrent with the four (4) month period of work release ordered by the Court in Respondent's criminal case, No. 08-CR-00991.
- C. Following the period of Suspension, Respondent's Physician and Surgeon License, No. 036069415, shall be placed on PROBATION for an Indefinite period of not less than two (2) years.
- D. During the period of PROBATION, Respondent shall adhere to the following:
1. Respondent shall abide by all the terms and conditions of his Probation ordered by the United States District Court for the Northern District of Illinois on September 28, 2009, in case No. 08-CR-0991 (hereinafter "Court-Ordered Probation"; see exhibit A attached hereto).
 2. Respondent shall take and complete an additional twenty (20) hours of Category I Continuing Medical Education credits directly related to proper billing practices and medical ethics within first six (6) months of this Probation. Said additional CMEs are NOT to be counted towards the annual CMEs required by the Medical Practice Act;
 3. During the period of Probation, Respondent shall provide the Department with quarterly reports which include:
 - i. current residential address and contact telephone number;
 - ii. if working as a physician, in a practice other than his own, Respondent shall provide a copy of any performance evaluation completed by his employer within the prior quarter. Respondent,

- shall at the beginning of Probation, provide the Department with objective documentation as to the frequency of employee performance evaluations;
- iii. a description of job duties, responsibilities and name of immediate supervisor, if employed in a medical practice other than his own;
 - iv. a copy of all incident reports within the prior quarter if employed in the medical practice other than his own; and
 - v. information, regarding any arrests, criminal, or civil actions filed, including DUI and/or other similar offenses against the Respondent;
4. Respondent shall notify the Department's Chief of Probation Investigations in writing of any change in employment and/or home address and/or telephone number within five (5) days;
5. If practicing in a solo practice, Respondent shall obtain a Practice Monitor, who is a licensed physician practicing in the State of Illinois in the same specialty as Respondent. The Practice Monitor shall be hired at the expense of Respondent and shall be pre-approved by the Chief Medical Coordinator of the Department. Respondent shall request that his practice monitor submit quarterly reports about scope, performance appraisals and billing practices.
6. The Practice Monitor shall agree to inform the Department immediately if there is evidence of inappropriate billing practices, professional misconduct, a violation of Respondent's probation or any violation of the laws and rules

governing the practice of medicine;

7. Respondent shall immediately notify the Department of any and all complaint(s) against him, including, but not limited to, any allegation of inappropriate billing practices.
8. Respondent shall immediately notify the Department should his relationship with any practice monitor cease and immediately take actions to select a new monitor and obtain the approval of the Chief Medical Coordinator;
9. If Respondent should begin working for another physician, Respondent shall request that his employer shall submit quarterly reports regarding Respondent's performance, evaluations and any and all other issues related to Respondent's work performance;

- E. Respondent agrees that any violation of the terms and conditions of this Consent Order or a violation of the terms of Probation is a violation of 225 ILCS 60/22(A)(15);
- F. Respondent agrees that if the Respondent violates the terms of his Court-Ordered Probation or if Respondent violates the terms of the Probation set forth in this Order, this Agreement permits the Director of the Division of Professional Regulations to issue an Order forthwith mandating the automatic, indefinite and

immediate suspension of Respondent's Physician and Surgeon License, License No. 036069415, for a minimum period of twelve (12) months. This suspension shall not preclude the Department from taking any other disciplinary or other actions it deems appropriate. In the event Respondent contests in writing (by the filing of an appropriate petition with the Department) the factual basis underlying said suspension within thirty (30) days of the imposition thereof, Respondent shall be afforded a hearing on the merits within thirty (30) days of the filing of said petition.

- G. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

AFFIDAVIT OF Temple Hall

I, Temple Hall, being duly sworn on oath, depose and make this affidavit on my personal knowledge and, if sworn as a witness in this matter, I would competently testify to the following facts;

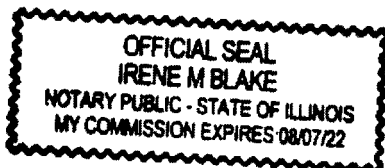
