ORDER

This matter is before the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Department") for the Automatic Suspension of the Illinois Physician and Surgeon License, No. 036.087679, of Hisham S. Sadek, M.D.

NOW, THEREFORE, I, JAY STEWART, DIRECTOR OF THE DIVISION OF PROFESSIONAL REGULATION OF THE ILLINOIS DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION ("Director"), after reviewing this matter and the exhibits attached hereto and referenced herein, do hereby find:

1. I have jurisdiction of the parties and subject matter herein;
2. On October 5, 2011, a Consent Order in case number 2010-01187 between Respondent and the Department was approved in full. A copy of said Consent order is attached hereto and incorporated by reference herein as Exhibit A;
3. On October 28, 2013, a Consent Order in case number 2010-01187-2 between Respondent and the Department was approved in full. A copy of said Consent Order is attached hereto and incorporated by reference herein as Exhibit B;
4. As a condition of the latter Consent Order, Respondent agreed to comply with the following provisions:

F. Respondent shall take and pass Ethics and Boundaries Post-Licensure Essay

Examination within first 12 months of said Probation;

N. If Respondent violates the terms and conditions of this Order, the Director of the Division of Professional Regulation may issue an Order forthwith mandating the automatic, immediate, indefinite suspension of Respondent's Illinois Physician License 036-087679 for a minimum of twelve (12) months. This indefinite suspension shall not preclude the Department from taking any other disciplinary or other actions it deems appropriate. In the event Respondent contests in writing (by the filing of an appropriate petition with the Department) the factual basis underlying said indefinite suspension within thirty (30) days of the imposition thereof, then Respondent shall be afforded a hearing on the merits within thirty (30) days from filing of said petition;

5. On November 25, 2014, Elizabeth Chillon, Acting Chief for the Probation Compliance Unit of the Department, reviewed the file of Respondent's compliance with the terms and conditions of the Consent Order and concluded that Respondent has violated the Consent Order in case number 2010-01187-2. A copy of the AFFIDAVIT of Elizabeth Chillon is attached hereto and incorporated by reference herein as Exhibit C.

IT IS THEREFORE ORDERED that Illinois Physician and Surgeon License No. 036.087679 heretofore issued to Hisham S. Sadek, M.D., to practice as a Physician and Surgeon in the State of Illinois is hereby **Indefinitely Suspended** for a minimum period of twelve (12) months.

IT IS FURTHER ORDERED that Hisham S. Sadek, M.D., immediately surrender said Illinois Physician and Surgeon License, No. 036.087679 and all other indicia of licensure to the

Illinois Department of Financial and Professional Regulation, Division of Professional Regulation. Upon failure to do so, the Department shall seize said License.


CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois, by Vladimir Lozovski, one of its attorneys, (hereinafter the "Department") and Hisham S. Sadek, M.D., (hereinafter the "Respondent"), hereby agree to the following:

STIPULATIONS

Hisham S. Sadek, M.D. is licensed as a Physician and Surgeon in the State of Illinois, holding License No. 036-087679. Said license is in Active status. At all times material to the matter(s) set forth in this Consent Order, the Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois had jurisdiction over the subject matter and parties herein.

Information has come to the attention of the Department that alleges that Respondent failed to inform his colleagues about his personal relationship with one of his patients, who was his wife, while she was admitted to Respondent's psychiatric services. The allegation(s) as set forth herein, if proven to be true, would constitute grounds for suspending, revoking or other discipline of Respondent's license as a Physician and Surgeon, on the authority 255 Illinois Compiled Statutes, Paragraph 60/22(A)(5).



An Informal Conference was held in this regard on June 1, 2011. Edward Rose, M.D. was present on behalf of the Illinois Medical Disciplinary Board and Vladimir Lozovski and Laura Forester were present for the Department. Respondent was present and represented by Michael R. Slovis, Esq. During the Informal Conference, Respondent described his care, treatment and evaluation of the patient-in-question. In addition, Respondent provided information regarding his personal relationship with his now ex-wife.

For purposes of this Consent Order only, Respondent acknowledges that should this matter proceed to a contested hearing, the Illinois Medical Disciplinary Board (the "Board") could find a violation of the Medical Practice Act. The Department and Respondent stipulate that the above acknowledgement is made only for the purposes of this Consent Order. In the event that this Consent Order is not approved by the Board or is not approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Director"), this acknowledgement shall not be admissible in any proceeding and the matter will be set for an evidentiary hearing on the merits as if this Consent Order had not been submitted. In addition, upon approval of this Consent Order, neither this acknowledgement nor this Consent Order may be utilized in any other proceeding, except one to enforce this Agreement.

Respondent has been advised of the right to have pending allegations reduced to written charges, the right to a hearing, the right to contest any charges brought, and the right to administrative review of this Consent Order. Respondent knowingly waives each of these rights, as well as the right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Medical Disciplinary Board or the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

Respondent and the Department have agreed, in order to resolve this matter, that Respondent, Hisham S. Sadek, M.D., be permitted to enter into a Consent Order with the Department, providing for the imposition of disciplinary measures which are fair and equitable under the circumstances and which are consistent with the best interests of the people of the State of Illinois.

CONDITIONS

WHEREFORE, the Department, through Vladimir Lozovski, its attorney, and Hisham S. Sadek, M.D., Respondent, agree:

- A. Physician and Surgeon License of Hisham S. Sadek, M.D., license No. 036-087679, is hereby placed on Indefinite Probation for minimum of three (3) year from the final approval of this Consent Order by the Director of the Division of Professional Regulation;
- B. Respondent shall pay a Fine in the amount of \$5000.00 dollars (five thousand dollars) being due within ninety (90) days of the effective date of this Consent Order Respondent shall submit a check payable to: the Illinois Department of Financial and Professional Regulation. Said fine shall be mailed to Illinois Dept. of Financial and Professional Regulation, Attention: CMU/Accounts Receivable - Fine Payments, 320 W. Washington St., 3rd Floor, Springfield, Illinois 62786. In the event that Respondent shall fail to pay the fine, and the Department is forced to initiate a collection effort to retrieve the fine, Respondent will be responsible for all costs and fees incurred by the collection process;
- C. During the period of probation, Respondent shall provide the Department with quarterly reports which include: (i) Current residential address and contact telephone number; (ii) Information regarding any patient complaints, billing disputes and/or problems; and (iii) Information, regarding any arrests, criminal, or civil actions filed, including DUI and/or

other similar offenses against the Respondent;

D. Respondent shall notify the Department's Chief of Probation Investigations in writing of any change in employment and/or home address and/or telephone number within ten (10) days;

E. While Respondent's said license is on Probation, Respondent shall take and complete additional thirty (30) category I Continuing Medical Education credits directly related to professional boundaries and medical ethics. Said additional CMEs are not to be counted towards the annual CMEs required by the Medical Practice Act.;

F. Respondent shall complete in-person Continuing Medical Education course related to professional boundaries and medical ethics within first 12 months of said Probation. Said in-person course shall be pre-approved by the Department's Medical Coordinator. Respondent's failure to complete in-person CME course within first 12 months of said Probation will result in an automatic indefinite suspension of his Illinois Physician and Surgeon License No. 036-087679 for a minimum period of six (6) months;

G. While Respondent's said license is on Probation, Respondent shall not treat and/or prescribe any medications for any of his family members and friends;

H. While Respondent's said license is on Probation, Respondent shall request the Department's Chairperson from any health-care institution, where Respondent is holding admitting privileges, to submit quarterly reports to the Department regarding Respondent's clinical performance, attendance record and any and all other issues arising out of Respondent's practice of medicine;

I. All the reports required to be submitted under the terms of this Probation shall be filed with the Department no later than 1/20, 4/20, 7/20 and 10/20 of each year during the full term of the Probation. Any reports required of Respondent hereunder shall be mailed to:

J. Respondent agrees that a violation of the terms and conditions of this Consent Order or a violation of the terms of probation is a violation of 225 ILCS 60/22(A)(15);

K. The Department and Respondent agree that if Respondent chooses to file a Petition for Restoration of his Physician and Surgeon License No. 036-087679, the Department will hold an Informal Conference prior to the Formal Hearing in order to attempt to amicably resolve Respondent's Petition for Restoration; and


L. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.




CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois, by Vladimir Lozovski, one of its attorneys, (hereinafter the "Department") and Hisham S. Sadek, M.D., (hereinafter the "Respondent"), hereby agree to the following:

STIPULATIONS

Hisham S. Sadek, M.D. is licensed as a Physician and Surgeon in the State of Illinois, holding License No. 036-087679. Said Illinois Physician and Surgeon License is currently in Active status. At all times material to the matter(s) set forth in this Consent Order, the Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois had jurisdiction over the subject matter and parties herein. Since October 2011, Respondent's Illinois Physician and Surgeon License No. 036-087679 has been on an Indefinite Probation for minimum of three (3) years after information has come to the Department's attention that Respondent failed to inform his colleagues about his personal relationship with one of his patient, who was his wife, while she was admitted to Respondent's psychiatric services.

Information has come to the attention of the Department that Respondent submitted inaccurate reports to the Department as a part of his Probation. The allegations set, if proven to be true, would constitute grounds for suspending, revoking and other discipline of Respondent's license on authority of 225 ILCS 60/22(A)(15).



As a result of the foregoing information, the Department held an Informal Conference on April 17, 2013. Richard Fay, D.C. was present on behalf of the Medical Disciplinary Board and Vladimir Lozovskiyy was present for the Department. Respondent was present and represented by Stephanie Wolfson, Esq. During the Informal Conference, Respondent provided information regarding his current practice as well as his plans for the future.

For purposes of this Consent Order only, Respondent acknowledges that should this matter proceed to a contested hearing, the Illinois Medical Disciplinary Board (the "Board") could find a violation of the Medical Practice Act. The Department and Respondent stipulate that the above acknowledgement is made only for the purposes of this Consent Order. In the event that this Consent Order is not approved by the Board or is not approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Director"), this acknowledgement shall not be admissible in any proceeding and the matter will be set for an evidentiary hearing on the merits as if this Consent Order had not been submitted. In addition, upon approval of this Consent Order, neither this acknowledgement nor this Consent Order may be utilized in any other proceeding, except one to enforce this Agreement.

Respondent has been advised of the right to have pending allegations reduced to written charges, the right to a hearing, the right to contest any charges brought, and the right to administrative review of this Consent Order. CONDITIONS

WHEREFORE, the Department, through Vladimir Lozovski, its attorney, and Hisham S. Sadek, M.D., Respondent, agree:

- A. Upon effective date of this Consent Order, Illinois Physician and Surgeon License of Hisham S. Sadek, M.D., License No. 036-087679, is hereby placed on an Indefinite Probation for a minimum of four (4) years;
- B. Respondent shall pay a Fine in the amount of \$50,000.00 (fifty thousand) to be paid in four (4) installments to be paid as follows:
 - i. first installment in the amount of \$10,000.00 (ten thousand) due on or before January 30, 2014;
 - ii. second installment in the amount of \$10,000.00 (ten thousand) is due on or before January 30, 2015;
 - iii. third installment in the amount of \$15,000.00 (fifteen thousand) is due on or before January 30, 2016; and
 - iv. fourth installment in the amount of \$15,000.00 (fifteen thousand) is due on or before January 30, 2017;

Said payments shall be mailed to Illinois Dept. of Financial and Professional Regulation, Attention: CMU/Accounts Receivable - Fine Payments, 320 W. Washington St., 3rd

- Floor, Springfield, Illinois 62786. In the event that Respondent shall fail to pay the fine, and the Department is forced to initiate a collection effort to retrieve the fine, the Respondent will be responsible for all costs and fees incurred by the collection process;
- C. During the period of probation, Respondent shall provide the Department with quarterly reports which include: (i) current residential address and contact telephone number; (ii) Respondent shall provide a copy of any performance evaluation completed by his employer within the prior quarter. Respondent, shall at the beginning of Probation, provide the Department with objective documentation as to the frequency of employee performance evaluations; (iii) description of job duties, responsibilities and name of immediate supervisor; (iv) copy of any and all incident reports within the prior quarter filled against Respondent; and (v) information, regarding any arrests, criminal, or civil actions filed, including DUI and/or other similar offenses against the Respondent;
- D. Respondent shall notify the Department's Chief of Probation Investigations in writing of any change in employment and/or home address and/or telephone number within ten (10) days;
- E. While Respondent's said license is on Probation, Respondent shall take and complete additional forty (40) category I Continuing Medical Education credits directly related to professional responsibilities and medical ethics. Said additional CMEs are not to be counted towards the annual CMEs required by the Medical Practice Act;
- F. Respondent shall take and pass Ethics and Boundaries Post-Licensure Essay Examination within first 12 months of said Probation;
- G. While Respondent's said license is on Probation, Respondent shall not treat and/or prescribe any medications for any of his family members and friends;


- H. Respondent shall abstain from the consumption of alcohol and/or use of mood altering and/or psychoactive drugs except those prescribed by a primary care and/or treating physician;
- I. While Respondent's said license is on Probation, Respondent shall request that the Department's Chairperson or an supervising Illinois Physician and Surgeon of every health care institution, where Respondent is holding clinical privileges, to submit quarterly reports to the Department regarding Respondent's clinical performance, attendance record and any and all other issues arising out of Respondent's practice of medicine;
- J. Respondent's Department's Chairperson(s) shall agree to inform the Department immediately if there is evidence of inappropriate behavior, professional misconduct, a violation of Respondent's probation or any violation of the laws and rules governing the practice of medicine;
- K. All the reports required to be submitted under the terms of this Probation shall be filed with the Department no later than 1/20, 4/20, 7/20 and 10/20 of each year during the full term of the Probation;
- L. Respondent agrees that a violation of the terms and conditions of this Consent Order or a violation of the terms of probation is a violation of 225 ILCS 60/22(A)(15);
- M. Respondent shall not violate the Illinois Medical Practice Act of 1987, any other federal and state laws related to the practice of medicine as well as any other federal and state laws;
- N. If Respondent violates any of the terms and conditions of this Order, the Director of the Division of Professional Regulation may issue an Order forthwith mandating the automatic, immediate, indefinite suspension of Respondent's Illinois Physician License 036-087679 for

a minimum of twelve (12) months. This indefinite suspension shall not preclude the Department from taking any other disciplinary or other actions it deems appropriate. In the event Respondent contests in writing (by the filing of an appropriate petition with the Department) the factual basis underlying said indefinite suspension within thirty (30) days of the imposition thereof, then Respondent shall be afforded a hearing on the merits within thirty (30) days from filing of said petition;

- O. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.
