CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois, by Vladimir Lozovskiy, one of its attorneys, (hereinafter the "Department") and Rupa Maitra, M.D. (hereinafter the "Respondent"), through Joseph Bogdan and Patrick Callahan, her attorneys, hereby agree to the following:

STIPULATIONS

Rupa Maitra, M.D. is licensed as a Physician and Surgeon in the State of Illinois, holding Illinois Physician and Surgeon License No. 036-104861. Said license is in Active status. At all times material to the matter(s) set forth in this Consent Order, the Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois had jurisdiction over the subject matter and parties herein.

Information has come to the attention of the Department that while Respondent was an acting Medical Director of Chester Mental Health Center, said hospital employed a physician who was excluded by HHS OIG from providing any care/treatment services for Medicare/Medicaid patients. The allegation(s) as set forth herein, if proven to be true, would constitute grounds for suspending, revoking or other discipline of Respondent's license as a Physician and Surgeon, on the authority 225 Illinois Compiled Statutes, Paragraph 60/22(A)(5).

Subsequently, the Department has filed a Formal Complaint and while the Complaint was pending the Department held an Informal Conference in this matter on June 19, 2019. Joseph Szokol, M.D. and Amy Derick, M.D. appeared for the Illinois Medical Disciplinary Board and Vladimir Lozovskiy, Staff Attorney, appeared for the Department. Respondent appeared in person along with her attorneys, Joseph Bogdan and Patrick Callahan. During the conference, Respondent provided information regarding her clinical background, training and experience and discussed the issued that precipitated the Department's Complaint.

For purposes of this Consent Order only, Respondent acknowledges that should this matter proceed to a contested hearing, the Illinois Medical Disciplinary Board (the "Board") could find a violation of the Medical Practice Act. Respondent has been advised of the right to a hearing, the right to contest any charges brought, and the right to administrative review of this Consent Order. Respondent knowingly waives each of these rights, as well as the right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Medical Disciplinary Board or the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

Respondent and the Department have agreed, in order to resolve this matter, that Respondent, Rupa Maitra, M.D. be permitted to enter into a Consent Order with the Department, providing for the imposition of disciplinary measures which are fair and equitable under the circumstances and which are consistent with the best interests of the people of the State of Illinois.

CONDITIONS

WHEREFORE, the Department, through Vladimir Lozovskiy, its attorney, and Rupa Maitra, M.D., Respondent, Joseph Bogdan and Patrick Callahan, her attorneys, agree:

A. Upon effective date of this Consent Order, Illinois Physician and Surgeon License of

Rupa Maitra, M.D., License No. 036-104861, is hereby reprimanded:

B. Respondent shall submit a proof of completion of ten (10) Category I CMEs in the area of professional responsibility within twelve (12) months of the effective date of this Consent Order;

C. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.
