

SUSPENSION ORDER

This matter having come before me on notice against Respondent, **EUGENE STEVEN KOSTIUK MD** (HEREINAFTER REFERRED TO AS "Respondent") filed with the DIVISION OF PROFESSIONAL REGULATION of the DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION of the State of Illinois by the Illinois Department of Revenue including a certification, signed by the Director of the Department of Revenue or designee, attesting to an unpaid tax liability and/or that a return was not filed and being duly advised in the premises.

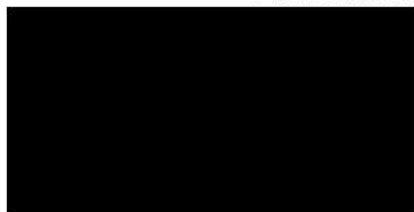
WHEREFORE, pursuant to 20 ILCS 2105/2105-15(g) and 68 Ill. Adm. Code 1100.560, it is hereby ordered, as follows:

1. Respondent's Certificate of Registration as a **LICENSED PHYSICIAN AND SURGEON**, License No. **036.037359**, be and is hereby **SUSPENDED**; Respondent shall immediately surrender said Certificate of Registration and all other indicia of licensure to the Department of Financial and Professional Regulation of the State of Illinois. Upon the failure to do so, the Department shall seize said Certificates of Registration;
2. Enforcement of the terms and conditions of this Order shall be stayed for sixty (60) days from the date of this order.
