CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois, by Vladimir Lozovski, one of its attorneys, (hereinafter the "Department") and Steven R. Lobacz, M.D. (hereinafter the "Respondent"), agree to the following:

STIPULATIONS

Steven R. Lobacz, M.D. is licensed as a Physician and Surgeon in the State of Illinois, holding Illinois Physician and Surgeon License No. 036-098563. Said licenses are in Active status. At all times material to the matter(s) set forth in this Consent Order, the Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois had jurisdiction over the subject matter and parties herein.

Information has come to the attention of the Department that Respondent had inappropriately prescribed Controlled Substances to several patients of his private practice that led to the surrender of DEA Registration for Cause in October 2022. In addition, during the investigation, the Department learned that Respondent is no longer practicing medicine due to ongoing medical condition. The allegation(s) as set forth herein, if proven to be true, may constitute grounds for suspending, revoking or other discipline of Respondent's license as a Physician and Surgeon, on the authority of 225 Illinois Compiled Statutes, Paragraph 60/22(A) (5) and (33).

Subsequently, the Department and Respondent engaged in negotiations for an amicable resolution of this matter. For purposes of this Consent Order only, Respondent acknowledges that should this matter proceed to a contested hearing, the Illinois State Medical Board (the "Board") could find a violation of the Medical Practice Act. In the event that this Consent Order is not approved by the Board or is not approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Director"), this acknowledgement shall not be admissible in any proceeding and the matter will be set for an evidentiary hearing on the merits as if this Consent Order had not been submitted.

Respondent has been advised of the right to have allegations to be reduced to written charges, the right to contest any charges brought against him, and the right to administrative review of this Consent Order. Respondent knowingly waives each of these rights, as well as the right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Illinois State Medical Board or the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.

Respondent and the Department have agreed, in order to resolve this matter, that Respondent, Steven R. Lobacz, M.D., be permitted to enter into a Consent Order with the Department, providing for the imposition of disciplinary measures which are fair and equitable under the circumstances and which are consistent with the best interests of the people of the State of Illinois.

CONDITIONS

WHEREFORE, the Department, through Vladimir Lozovski, its attorney, and Steven R. Lobacz, M.D., Respondent, agree:

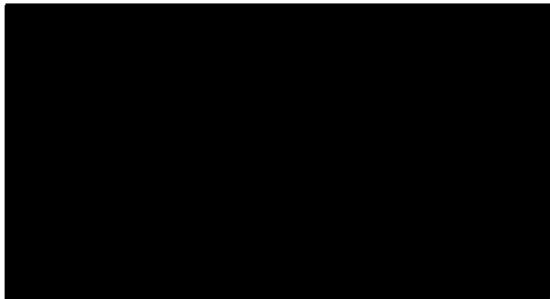
- A. Upon effective date of this Consent Order, Illinois Physician and Surgeon License

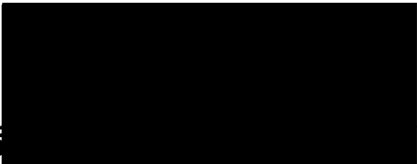
