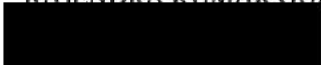

Please take notice that pursuant to the Illinois Medical Practice Act of 1987, 225 ILCS 60/et seq. and the Act's Administrative Rules, 68 IAC 1285/et seq., the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation ("Department") has determined you may be unfit for licensure and intends to Refuse to Renew your Illinois Physician and Surgeon License due to the following:

<u>Allegation</u>	<u>Statute/Rule Violated</u>
From November 2017 to August 2018, Respondent failed to properly monitor psychotropic medication changes and treatment plan changes in Patient L.J.; and failed to treat and monitor the patient for symptoms of prolonged the QT interval despite positive EKG findings and continued treatment with drugs that prolonged the QT interval. Respondent acts or omissions caused, or materially contributed, to Patient L.J. death in August 2018.	225 ILCS 60/22(A)(4) and (5), 68 IAC 1285.240, and 20 ILCS 2105/2105-130.

You are hereby notified that you have thirty (30) days to file a request for hearing to contest this Notice. Failure to request a hearing within thirty (30) days after service of this Notice may result in the Director of the Department issuing an Order refusing renewal of your license(s).
