### **SUMMARY SUSPENSION ORDER**

The Medical Licensing Board of Indiana ("Board"), pursuant to the authority of Indiana Code § 4-21.5-4-1 et seq. and Indiana Code § 25-1-9-10, at the October 24, 2002 meeting, by a vote of 5-0-0, SUMMARILY SUSPENDS the license held by Deborah Ann Redd, M.D., ("Respondent") for 90 days, as the Board finds that an emergency exists and that the Respondent represents a clear and immediate danger to the public health and safety if allowed to practice medicine in the State of Indiana.

Deputy Attorney General N. Renee Gallagher represented the State of Indiana. The Respondent was present and not represented by counsel.

Respondent represents a clear and immediate danger to the public health and safety and, if allowed to continue to practicing as a licensed physician, Respondent will continue to represent a clear and immediate danger to the public health and safety for the following reasons:

a. The Respondent called in and picked up prescriptions for several controlled substances for two of her family members, Sue Dukehart and Linda Castle, from approximately June of 2002 through September of 2002. Both patients were later discovered to be the Respondent's sisters. On or about September 10, 2002, both Ms. Dukehart and Ms. Castle were shown a printout of the drugs the Respondent had prescribed for them and had picked up from the Walgreen's pharmacy located at 5830 N.

Clinton Street, Fort Wayne, Indiana. Both Ms. Dukehart and Ms. Castle admitted that they had not received any of the prescription drugs reported on the printout. Therefore, the Respondent has engaged in fraud or material deception in the course of providing professional services or activities, in violation of Indiana Code § 25-1-9-4(a)(1);

- b. The Respondent knowingly prescribed controlled substances for her sisters and picked up said prescriptions. However, Respondent used the controlled substances for her own use. Respondent has knowingly violated a state statute or rule, or federal statute or regulation, regulating the profession in question, to-wit: 844 IAC 5-2-5 by failing to exercise reasonable care in her prescriptive authority and following generally accepted professional theory and practice, in violation of Indiana Code § 25-1-9-4(a)(3);
- c. The Respondent has become unfit to practice because of her abuse or addiction to controlled substances and her failure to keep abreast of current professional theory or practice, in violation of Indiana Code § 25-1-9-4(a)(4).

This **NON-FINAL** emergency order is based on the evidence in the Board's file, the evidence presented to the Board by the Petitioner and the Respondent's testimony.

WHEREFORE, RESPONDENT IS ORDERED to immediately cease and desist all acts constituting the practice of medicine for a period of 90 days from the date of this Order.

IT IS FURTHER ORDERED, that Respondent shall immediately surrender all indicia of licensure, including her pocket license and wall license, to the Board in care of the Health Professions Bureau, 402 West Washington Street, Room 041, Indianapolis, Indiana 46204.

## PETITION FOR SUMMARY SUSPENSION

The State of Indiana, by Counsel, N. Renee Gallagher, Deputy Attorney General, moves the Medical Licensing Board of Indiana ("Board") to suspend the license of Deborah Ann Redd, M.D. ("Respondent") for 90 days, and in support of its petition states the following:

- 1. Respondent is a licensed physician in the State of Indiana.
- 2. This Board has jurisdiction to suspend Respondent's license in accordance with the provisions of Indiana Code § 4-21.5-4-3 et seq. and Indiana Code § 25-1-9-10.
- 3. Respondent represents a clear and immediate danger to the public health and safety and, if allowed to continue to practicing as a licensed physician, Respondent will continue to represent a clear and immediate danger to the public health and safety for the following reasons:
- a. The Respondent called in and picked up prescriptions for several controlled substances for two of her patients, Sue Dukehart and Linda Castle. Both patients were later discovered to be the Respondent's sisters. On or about September 10, 2002, both Ms. Dukehart and Ms. Castle were shown a printout of the drugs the Respondent had prescribed for them and had picked up from the Walgreen's pharmacy located at 5830 N. Clinton Street, Fort Wayne, Indiana. Both Ms. Dukehart and Ms. Castle admitted that they had not received any of the prescription drugs reported on the printout. Therefore, the Respondent has engaged in fraud or material deception in the course of providing professional services or activities, in violation of Indiana Code § 25-1-9-4(a)(1);
- b. The Respondent knowingly prescribed controlled substances for her sisters and picked up said prescriptions. However, Respondent used the controlled substances for her own

use. Respondent has knowingly violated a state statute or rule, or federal statute or regulation, regulating the profession in question, to-wit: 844 IAC 5-2-5 by failing to exercise reasonable care in her prescriptive authority and following generally accepted professional theory and practice, in violation of Indiana Code § 25-1-9-4(a)(3);

c. The Respondent has become unfit to practice because of her abuse or addiction to controlled substances and her failure to keep abreast of current professional theory or practice, in violation of Indiana Code § 25-1-9-4(a)(4).

WHEREFORE, the State of Indiana requests that this Board set a hearing on this petition for summary suspension and suspend Respondent's license for a period of ninety (90) days and for all other proper relief.

### **COMPLAINT**

The State of Indiana ("Petitioner"), by counsel, Deputy Attorney General, N.

Renee Gallagher, on behalf of the Office of the Attorney General ("Petitioner"), and pursuant to Indiana Code § 25-1-7-7 et seq., Ind. Code § 25-1-5-3, Ind. Code § 25-22.5 et. seq., the Administrative Orders and Procedures Act, Ind. Code § 4-21.5-3 et seq. and Ind. Code § 25-1-9 et. seq. files its Complaint against the Medical license of Deborah Ann Redd, M.D. ("Respondent"), and in support alleges and states:

### **FACTS**

- 1. Respondent's address on file with the Board is: 1535 Elm Street, Terrre Haute, Indiana 47807 and c/o Beacon House, 2456 N. Bolton Avenue, Indianapolis, Indiana 46218. The Respondent is a duly licensed physician in the State of Indiana under license number 01048156.
- 2. In 2001 and 2002, the Respondent called in and picked up prescriptions for several controlled substances for two of her patients, Sue Dukehart and Linda Castle.
- 3. Both patients were later discovered to be the Respondent's sisters. On or about September 10, 2002, both Ms. Dukehart and Ms. Castle were shown a printout of

the drugs the Respondent had prescribed for them and had picked up from the Walgreen's pharmacy located at 5830 N. Clinton Street, Fort Wayne, Indiana.

4. Both Ms. Dukehart and Ms. Castle admitted that they had not received any of the prescription drugs reported on the printout.

### COUNT I

- 5. Petitioner incorporates by reference paragraphs 1-4 herein.
- 6. The Respondent has engaged in fraud or material deception in the course of providing professional services or activities, in violation of Indiana Code § 25-1-9-4(a)(1), in that, she authored and filled prescriptions for two alleged patients and kept the drugs for the Respondent's own use.

## COUNT II

- 7. Petitioner incorporates by reference paragraphs 1-4 herein.
- 8. Respondent is in violation of Indiana Code § 25-1-9-4(a)(3), in that, she filled prescriptions for alleged patients and then used the medications for the Respondent's own personal use, in particular, the Respondent has knowingly violated a state statute or rule, or federal statute or regulation, regulating the profession in question, to-wit: 844 IAC 5-2-5 by failing to exercise reasonable care in her prescriptive authority and following generally accepted professional theory and practice.

## **COUNT III**

- 9. Petitioner incorporates by reference paragraphs 1-4 herein.
- 10. The Respondent has become unfit to practice because of her abuse or addiction to controlled substances and her failure to keep abreast of current professional theory or practice, in violation of Indiana Code § 25-1-9-4(a)(4).

WHEREFORE, the Petitioner demands an Order against the Respondent, that:

- 1. Imposes the appropriate disciplinary sanction;
- 2. Directs the Respondent to pay all the costs incurred by the Office of the Attorney General in the prosecution of this case within thirty (30) days of the Board's Order; and
  - 3. Provides any other relief the Board deems just and proper.

# FINDINGS OF FACT AND ORDER

The Medical Licensing Board of Indiana ("Board") held an Administrative Hearing on January 22, 2004, in Room C of the Indiana Government Center, South, 402 West Washington Street, Indianapolis, Indiana 46204, to consider a proposed settlement agreement regarding reinstatement of the licensure of Deborah Ann Redd, M.D. ("Respondent").

The State of Indiana was represented by Kate Sinn, Deputy Attorney General. The Respondent appeared in person. The Board, after considering the settlement proposal and taking official notice of its files in this case, by a vote of 5-0-1, issues the following Findings of Fact:

# FINDINGS OF FACT

- 1. Respondent is a licensed medical doctor holding Indiana license number 01048156.
- 2. In 2001 and 2002, the Respondent called in and picked up prescriptions for several controlled substances for two of her patients, Sue Dukehart and Linda Castle. Both patients were later discovered to be the Respondent's sisters.

- 3. On or about September 10, 2002, both Ms. Dukehart and Ms. Castle were shown a printout of the drugs the Respondent had prescribed for them and had picked up from the Walgreen's pharmacy located at 5830 N. Clinton Street, Fort Wayne, Indiana.
- 4. Both Ms. Dukehart and Ms. Castle admitted that they had not received any of the prescription drugs reported on the printout.
- 5. On October 24, 2002, the Board summarily suspended Respondent's medical license.
  - 6. On June 13, 2003, the State filed a Complaint against the Respondent.
- 7. The Respondent's license continued to be summarily suspended since October 24, 2002, by agreement of the parties.
- 8. The Respondent has completed treatment at the Rush Behavioral Health Center ("Rush") in Downers Grove, Illinois, and has received recommendations from her Rush health care providers concerning her further treatment and improvement in the form a Caduceus Aftercare Program.
- 9. The Respondent has agreed to comply with the Caduceus Aftercare Program as set forth in the recommendation of Rush and has been in compliance with the Program since March of 2003.
- 10. On April 8, 2003, the Respondent signed a Continuing Care Contract with the Physician Assistance Program of the Indiana State Medical Association (ISMA).
- 11. The Respondent requests that her license be reinstated, and the State has no objection to this request, so long as the Respondent is compliant with the recommendations of ISMA and Rush.

## **ULTIMATE FINDINGS OF FACT**

- 1. The conduct described above is in violation of the following:
- a) Indiana Code § 25-1-9-4(a)(1)(B) in that Respondent has engaged in fraud or material deception in the course of providing professional services or activities;
- b) Indiana Code § 25-1-9-4(a)(3) in that Respondent has knowingly violated a state statute or rule, or federal statute or regulation, regulating the profession in question, to wit: 844 IAC 5-2-5 in that Respondent failed to exercise reasonable care in her prescriptive authority and following generally accepted professional theory and practice; and
- c) Indiana Code § 25-1-9-4(a)(4)(B) and (D) in that Respondent has failed to keep abreast of current professional theory or practice and become unfit to practice because of her abuse or addiction to controlled substances.

### **ORDER**

Based upon the above Findings of Fact, the Board issues the following Order:

- Respondent's license is reinstated and Respondent is placed on INDEFINITE PROBATION.
- 2. Respondent may not seek to have probation withdrawn for a period of five (5) years.
- 3. Respondent may not seek to have probation modified for a period of three (3) years.

- 4. During probation, the following terms and conditions shall govern Respondent's license:
  - a) The Respondent shall be compliant with all terms and conditions of the ISMA contract. A copy of said contract shall be provided to the Board 30 days from the date of this order.
  - b) The Respondent shall comply with the Caduceus Aftercare Program as set forth in the recommendation of Rush Behavior Health Center.
  - monitoring agreement and a preceptor for approval by the Board or the Board Designee.
  - d) The Respondent shall cause her preceptor to submit a written report to the Board regarding Respondent's progress. The reports are to be monthly for the first three months and quarterly for the remainder of the Respondent's probation.
  - e) The Respondent shall see a counselor at least one (1) time per month.
  - f) The Respondent shall cause her counselor (currently June Thompson) to submit written quarterly reports to the Board as to the status of Respondent's therapy.
  - g) The Respondent shall see a psychiatrist at least one time per quarter and the Respondent shall cause her psychiatrist (currently Catherine Herod, M.D.) to submit quarterly reports to the Board.
  - h) The Respondent shall personally appear before the Board quarterly.

- i) The Respondent shall completely abstain from mood altering substances, including alcohol, except as prescribed by a duly licensed practitioner for a documented legitimate purpose. The treating physician shall report any such medical treatment and prescribing to the Board within ten (10) days after the date of treatment. Respondent must inform the treating physician of this responsibility and ensure timely compliance.
- j) Respondent must maintain a controlled substances log, which shall include the patient's initials, the date, the patient's complaint, the medication prescribed, and date last prescribed and the amount. Respondent must make the controlled substance log and patient charts available for review by the Board.
- 5. A violation of this Order, or otherwise reported non-compliance with the statutes and regulations relating to the competent practice of medicine, may result in the State requesting an emergency suspension of Respondent's license, pending a reinstatement of the initial action giving rise to this resolution, an Order to Show Cause as may be issued by the Board, or a new cause of action pursuant to Indiana Code § 25-1-9-4(a)(10), any or all of which could lead to additional sanctions up to and including revocation of the Respondent's license.

#### ORDER WITHDRAWING PROBATION

Hearing having been held on April 23, 2009, on the Respondent's petition for withdrawal of probation, the Board, by a vote of 6-0, now issues its Order Withdrawing Probation as follows:

#### FINDINGS OF FACT

- 1. This matter is before the Board on Deborah Ann Redd's (hereinafter "Respondent") petition for withdrawal of her probation. In its Findings of Fact and Order issued on April 7, 2004, the Board placed the Respondent, whose license had been summarily suspended, on probation indefinitely. Various terms and conditions were imposed.
- 2. The Respondent has established that the deficiency that required disciplinary action has been remedied. Dr. Frick and Rick Gustafson testified on the Respondent's behalf. Dr. Frick said she had been a "model participant" in the Indiana State Medical Association's Physician Assistance Program and that he "would endorse [probation withdrawal] enthusiastically."

#### CONCLUSIONS OF LAW

1. Indiana Code section 25-1-9-9(b) states in pertinent part that:

The board may withdraw or modify [a] probation [imposed in a disciplinary proceeding] if it finds, after a hearing, that the deficiency that required disciplinary action has been remedied, or that changed circumstances warrant a modification of the order.

2. Because the Respondent has established that the deficiency that required disciplinary action has been remedied, she qualifies for withdrawal of her probation.

### **ORDER**

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that the Respondent's petition for withdrawal of her probation is granted and therefore her probation is withdrawn.
