FINAL ORDER

NOW this 12<sup>th</sup> day of June, 2009 the above captioned matter comes before the Board on the application of Kurt Roberts Guindon, M.D. for a license to practice medicine and surgery. The applicant appears by and through Trey Meyer of Skepnek, Fagan, Meyer and Davis, 900 Massachusetts St., Ste. 601, Lawrence, KS 66044. Board Staff appears by and through Kathleen Selzler Lippert. There are no other appearances. The Board, being apprised of the premises, being familiar with the facts of this matter makes the following findings of fact and conclusions of law:

1. The applicant, Kurt R. Guindon, M.D., applies for a license to practice medicine and surgery.
2. Board staff opposes the application for a license to practice medicine and surgery as more fully set forth in its opposition to the application for a license to practice to practice medicine and surgery.
3. The applicant's license to practice medicine was suspended in an Emergency Proceeding on April 25, 2008.
4. The applicant's license to practice medicine lapsed on July 31, 2008 and was cancelled as a matter of law.

5. The Board finds the applicant was found *In the Matter of Kurt Roberts Guindon, MD, Kansas License No. 04-21448, 08 HA 117* (Kansas State Board of Healing Arts, 2009) to have been in violation of the Kansas Healing Arts Act, specifically K.S.A. 65-2836(a)(b)(r)(y) and (z).

6. *In the Matter of Kurt Roberts Guindon, id.*, the applicant's license to practice medicine was limited for two years from the time the applicant's license to practice medicine is approved, not counting periods of unemployment. During this time period, Kurt R. Guindon is only allowed to provide patient care in a hospital or clinical environment where his responsibilities are focused on patient care and treatment. Kurt R. Guindon shall comply with the limitations set forth in the Initial Order and the Final Order of the Board. Kurt R. Guindon shall provide updates to the Board from his employer every six months, which indicates the responsibilities that Dr. Guindon has undertaken in the previous six months. Dr. Guindon's employer shall also provide updates to the Board of Dr. Guindon's projected responsibilities during the next six months. Periods of unemployment will not count towards the completion of the two year limitation on his license.

7. Kurt R. Guindon shall report to the Board any unemployment or the change of employment immediately. Periods of unemployment will not count towards the completion of the two year limitation on Kurt R. Guindon's license to practice medicine and surgery. Kurt R. Guindon is responsible to provide proof to the Board that he is complying with the limitation set forth in this order.


8. Upon completion of the two year limitation on his license and appropriate proof of the same, the limitations on the license of Kurt R. Guindon will be lifted.

WHEREUPON, a limited license to practice medicine and surgery is issued to Kurt R. Guindon, M.D.

**PLEASE TAKE NOTICE** that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon Jack Confer, the Board's Acting Executive Director, at 235 SW Topeka Blvd., Topeka, KS 66603.


