COMPLAINT

Comes now the Complainant, Olney M. Patrick, M.D., Chairman of the Kentucky Board of Medical Licensure's Inquiry Panel (B), and on behalf of the Panel states for its Complaint against Respondent, Christine B.L. Adams, M.D., as follows:

- 1. Respondent is licensed to practice medicine in the Commonwealth of Kentucky as is thereby subject to review and discipline by the Kentucky Board of Medical Licensure pursuant to KRS 311.530, et seq.
- 2. That Respondent testified in a Jefferson (Kentucky) Circuit Court proceeding that Mr. "A" sexually abused two (2) of his daughters when the clinical information and documentation is not sufficient to justify such testimony. Respondent's conduct and testimony as outlined above constitutes dishonorable, unethical or unprofessional conduct of a character likely to deceive, defraud or harm the public or any member thereof in that she failed to follow certain well-established clinical guidelines prior to her testimony that Mr. "A" sexually abused his daughters. This conduct is calculated or has the effect of bringing the medical profession into disrepute in that it is a departure from, or a

failure to conform to the standards of acceptable and prevailing medical practice within the Commonwealth of Kentucky.

- 3. Accordingly, sufficient grounds exist for discipline to be taken against the license to practice medicine in the Commonwealth of Kentucky held by Respondent pursuant to KRS 311.595(8) and 311.597(4).
- 4. Respondent is directed to respond to the allegations delineated in the Complaint within thirty (30) days of service thereof and is further given notice that:
- (a) Her failure to respond may be taken as an admission of the charges; and
- (b) She may appear alone or with counsel, may cross-examine all prosecution witnesses and offer evidence in his defense.

WHEREFORE, Complainant prays that appropriate disciplinary action be taken against the license to practice medicine held by Christine B.L. Adams, M.D.
