
1. Dr. Parks agrees to permanently surrender his DEA permit to the Kentucky Board of Medical Licensure, effective upon entry of this Order.

2. Subsequent to the entry of this Order, under no circumstances shall Dr. Parks be allowed to prescribe/dispense/administer or otherwise professionally utilize any controlled substances (Schedule II, IIN, III, IIIN, IV or V) as defined by state and federal law.


In the event it is determined that Dr. Parks is in violation of any of the terms or conditions of this Agreed Order, it is understood and agreed that such violations shall further constitute a violation of KRS 311.560.





AMENDED COMPLAINT

Comes now the Complainant, Olney M. Patrick, M.D., Chairman of the Kentucky Board of Medical Licensure's Inquiry Panel B, and on behalf of the Panel states for its Amended Complaint against Respondent, John H. Parks, M.D., as follows:

1. Respondent is licensed to practice medicine in the Commonwealth of Kentucky and is thereby subject to review and discipline by the Kentucky Board of Medical Licensure or its appropriate Panel pursuant to KRS 311.530, et seq.

2. That Respondent, a psychiatrist, fails to manage medications and his psychiatric patients in a safe and effective manner. Additionally, Respondent's utilization of medications and passes is frequently dangerous. Further, in his psychiatric practice, Respondent utilizes treatment modalities and/or regimens that are unconventional and of no medical benefit to the patients.

3. That on or about June 5, 1991, the Medical Staff Executive Committee of Charter Ridge Hospital (Lexington, Kentucky) summarily suspended Respondent's prescribing privileges at their facility based on their determination that Respondent's "prescribing practice fell outside the generally accepted parameters of the practice of psychiatry" and that said suspension was "taken in the best interest of patient care at the

hospital in the reasonable belief that said action is necessary to reduce the substantial likelihood of and prevent injury to the health and welfare of patients treated at the hospital."

4. Accordingly, sufficient grounds exist for discipline to be taken against the license to practice medicine in the Commonwealth of Kentucky held by Respondent, in that the conduct delineated above in Paragraph Nos. Two (2) and Three (3) constitute violation of KRS 311.595(8) and KRS 311.595(20). Specifically, Respondent's conduct as delineated above in Paragraph No. Two (2), is calculated or has the effect of bringing the medical profession into disrepute as his conduct failed to conform to the principles of medical ethics and was a departure from and a failure to conform to the standards of acceptable and prevailing medical practice within the Commonwealth of Kentucky in violation of KRS 311.597(4).


5. Respondent is directed to respond to the allegations delineated in the Amended Complaint within thirty (30) days of service thereof and is further given notice that:

(a) His failure to respond may be taken as an admission of the charges; and

(b) He may appear alone or with counsel, may cross-examine all prosecution witnesses and offer evidence in his defense.

WHEREFORE, Complainant prays that appropriate disciplinary action be taken against the license to practice medicine held by John H. Parks, M.D.



COMPLAINT

Comes now the Complainant, Olney M. Patrick, M.D., Chairman of
the Kentucky Board of Medical Licensure's Inquiry Panel B, and on behalf
of the Panel states for its Complaint against Respondent, John H. Parks,
M.D., as follows:

1. Respondent is licensed to practice medicine in the
Commonwealth of Kentucky and is thereby subject to review and discipline
by the Kentucky Board of Medical Licensure or its appropriate Panel
pursuant to KRS 311.530, et seq.

2. That Respondent, a psychiatrist, fails to manage medications
and his psychiatric patients in a safe and effective manner.
Additionally, Respondent's utilization of medications and passes is
frequently dangerous. Further, in his psychiatric practice, Respondent
utilizes treatment modalities and/or regimens that are unconventional and
of no medical benefit to the patients.

3. Accordingly, sufficient grounds exist for discipline to be
taken against the license to practice medicine in the Commonwealth of
Kentucky held by Respondent, in that the conduct delineated above in
Paragraph No. Two (2) constitutes dishonorable, unethical and
unprofessional conduct in violation of KRS 311.595(8). Specifically,
Respondent's conduct is calculated or has the effect of bringing the

medical profession into disrepute as his conduct failed to conform to the principles of medical ethics and was a departure from and a failure to conform to the standards of acceptable and prevailing medical practice within the Commonwealth of Kentucky in violation of KRS 311.597(4).


4. Respondent is directed to respond to the allegations delineated in the Complaint within thirty (30) days of service thereof and is further given notice that:
