**ORDER FOR REINSTATEMENT  
OF UNRESTRICTED LICENSE**

This matter is before the Louisiana State Board of Medical Examiners (the "Board") on the request of Lynn Simon, M.D., ("Dr. Simon") for the unrestricted reinstatement of his license to practice medicine in this state. Previously, by Consent Order entered in the year 2011, the license of Dr. Simon, was placed on probation for five (5) years, subject to his compliance with and satisfaction of specified terms, conditions, and restrictions<sup>1</sup>.

Having served the term of his probation Dr. Simon appeared before the Board on March 14, 2016. Based on its review of the history of this matter and all of the information received and reviewed, the Board concluded that Dr. Simon had satisfied the terms of its prior Order and that the public interest would be properly served and protected by the reinstatement of his license to practice medicine in this state. Accordingly, in considering of the foregoing and pursuant to the authority vested in the Board by La. Rev. Stat. §37:1285(D) and the Consent Order previously entered herein:

**IT IS ORDERED** that the license of Lynn Simon, M.D. to engage in the practice of medicine in the State of Louisiana, as evidenced by Certificate No. MD 013348, is hereby effective as of the date hereof, **REINSTATED WITHOUT PROBATION**; *provided, however*, that such reinstatement of licensure and Dr. Simon's continuing exercise of the rights and privileges there under shall, be conditioned upon his continued compliance with the lifetime prohibitions contained in Paragraph (1) of such Order against his prescribing narcotic



medication, including Suboxone, and Paragraph (4) of such Order against his serving as a collaborating physician for a nurse practitioner or supervising physician for a physician assistant.

**IT IS FURTHER ORDERED** that except as expressly provided herein, the Consent Order of March 14, 2011, and all its terms, conditions and restrictions are hereby vacated and superseded by this Order.

**IT IS FURTHER ORDERED** that this Order shall be, and shall be deemed to be, a public record.
