On 9-5-2015 at approx. 1230 hrs I was dispatched to the ELPD desk to meet with a father who was bringing his son to the station. Dispatched advised that the son was involved in a hit and run accident last night in East Lansing.

At the desk I met with a subject who identified himself as Maninderpal Singh Dhillon u/m 02-09-1988. Dhillon advised he was involved in an accident last night in East Lansing but was not sure where. Dhillon advised his vehicle is a White Lexus IS350 with a MI reg of 6JPJ71.

Dhillon's address is 1224 E Saginaw #40 in East Lansing. Dhillon's permanent address is 3607 Heron ridge Rochesterhills MI 48309. Dhillon's phone number is 248-495-8658 and email address is msdpnjbi88@gmail.com. Dhillon's is currently employed as a resident at Sparrow Hospital in the Psychiatric unit.

Dhillon advised he worked at 12 hr shift on 9-4-2015 which ended at 6:30pm. Dhillon advised he arrived at the Hop Cat in East Lansing at 7:30pm. Dhillon stated he remained at the Hop Cat until approximately 8:30pm and during this time he drank two beers. Dhillon advised the two beers consisted of a Final Absolute and a Golden Monkey. Dhillon stated that both of these beers contain a higher amount of alcohol than a normal beer.

Dhillon advised that at 8:30pm he went to Dublin Square in East Lansing. Dhillon advised he drank one 12 or 16oz beer at Dublin. Dhillon stated he remained at Dublin until approximately 11pm. Dhillon advised that he just walked around East Lansing for a while before heading home.

Dhillon advised that he did not feel he was or intoxicated or buzzed. Dhillon stated he just felt very tired after leaving the bar since he worked all day.

Dhillon stated he parked his Lexus in city lot #1 in downtown East Lansing. I asked Dhillon if he was driving the car and Dhillon stated he could not recall. I asked Dhillon who was driving and he stated he did not know. I asked Dhillon what he recalled about the accident and he stated he did not recall anything. I asked Dhillon if he was driving when the accident happened and again Dhillon advised he could not recall.

I asked Dhillon how he got home and Dhillon stated he took a cab. Dhillon advised he did not know what Cab Co. it was, how he got a hold of a cab, or where the cab picked him up. Dhillon also advised he did not think anyone was with him and that he paid for the cab using his credit card.

I had not told Dhillon where the accident happened. I asked Dhillon that, and he thought somewhere maybe around Gunson. Dhillon then stated he felt he probably walked back towards the downtown area and this is where he found a cab.

I asked Dhillon who he went to the bar with. Dhillon advised he went with three people that he works with. They are Matt, Nolan, and Fadi. Dhillon stated he did not know any of the last names. I asked Dhillon if any those individuals were with him when he left and he stated that Matt and Nolan were definitely. Dhillon said it was possible that Fadi was with him.

INJURIES

I asked Dhillon what if any injuries he suffered. Dhillon stated that when his father and sister came to his apartment this morning around 9am he was just disoriented. Dhillon advised they had a hard time waking him up.

Dhillon stated from the accident he suffered bruising around both eyes. Bruising along the left side of his neck, small bruises and cuts on both upper arms, abrasions on his left knee and a cut on his left ankle.

I ask Dhillon to remove his shirt so I could see the bruises around his neck/collarbone area. These bruises were consistent from being sustained by a seat belt. This bruising would place Dhillon on the driver's side of the vehicle. Dhillon never made any mention of possible being in the back seat of the vehicle.

I took photos of Dhillon injuries. These were placed into evidence.

RO and Ofc. Park were dispatched to 801 Beechlawn Ct. on the report of a traffic accident. Dispatch further indicated that a vehicle had crashed into the house. Dispatch also stated that the driver of the vehicle had fled.

ARRIVAL

RO arrived on scene. RO was pointed by the neighbors to the car in the S yard of 801 Beechlawn Ct. The vehicle had in fact crashed into the side of the duplex.

CHECK OF VEHICLE

RO walked into the side yard past the plastic fence. The vehicle was up against the residence. RO looked in the passenger window of the vehicle and did not see anyone in the vehicle. The vehicle was smoking from the engine area. The vehicle had crushed the air conditioner into the side of the residence. The vehicle had also smashed a hole in the cement foundation. This hole was approx. 4 ft. wide.

FIRE DEPARTMENT

RO then requested the fire department since the vehicle's engine was smoking and there was now an electrical issue with the air conditioner being completely smashed into the side of the house.

K9 SEARCH

Ofc. Park and his partner did do a K9 search; see Supp.

INTERIOR OF VEHICLE

RO then began looking at the interior of the vehicle. RO did locate on the bottom floor of the driver's seat a MasterCard with the brand name of Sears on it. This was in the name of the registered owner, the suspect, Maninderpal Singh Dhillon.

On the R front passenger floor area, RO did find the suspect's wallet with his driver's license still in it. RO also found the suspect's cell floor lying on the passenger floor.

RO found in the passenger seat a pager with his name on it and the phone number for the pager of 232-0997. RO also found in the vehicle his Sparrow Hospital badge indicating he was a resident with psychiatry. RO also found an MSU College of Osteopathic Medicine, Detroit Medical Center ID card.

RO did provide Ofc. Kuhn the cell phone. Ofc. Kuhn did speak with the suspect's mother and father concerning the accident. They could not give RO's a location of the suspect's apt. except to indicate it was by Saginaw and Hagadorn.

PHOTOGRAPHS

RO did take photographs of the accident scene. RO did take 19 photographs with Sgt. Neff's camera.

ELFD

ELFD had responded to the scene. They did speak with the on-call fire representative that indicated with the damage to the air conditioner and electrical system, they did not at that time want the resident Amanda Wildeboer staying there with her four small children.

ACCIDENT REPORT

RO did start an Accident Report. It appears the suspect was NB Alton at a high rate of speed. RO would estimate 40+ mph. Suspect vehicle blew the stop sign at Alton and Saginaw. Suspect vehicle crossed the five lanes of Saginaw and hit the cement curb on the NW curb. The suspect vehicle then went airborne and crashed into the lawn. The suspect vehicle then went through the plastic fence into the yard, striking the air conditioner and pushing that into the side of the house.

Three out of the four tires of the vehicle were flattened and damaged.

SUSPECT

The suspect had come into ELPD with his sister Pam and his father. They spoke with Ofc. M. Potter concerning the accident. Ofc. Potter also took photographs of the suspect's injuries which had been attached to this report.

RO spoke to Ofc. Potter and at that time the suspect kept indicating to Ofc. Potter that he could not remember what happened. Somehow he was dazed and that later on he found a cab and somehow ended up home.

The suspect wanted his cell phone and other property that RO had seized. Ofc. Potter advised him that RO was going to contact him or to contact RO.

CONTACT WITH SUSPECT'S SISTER

RO did make contact with the suspect's sister Pam at 248-804-3339. RO did inform her that RO did have the suspect's property and that RO would be able to return that this evening.

CONTACT WITH SUSPECT

The suspect and his sister did come into ELPD. RO asked the suspect what happened. This time the suspect indicated that he fell asleep. RO informed the suspect he passed out due to his intoxication level.

CITATIONS

RO did issue the suspect two citations; Wreckless Driving and Leaving the Scene of an Accident.

PROPERTY

The listed property in the report was returned to the suspect. The property was his MasterCard, his cell phone, his wallet, his MSU ID card, his Sparrow ID card and pager.
