CONSENT ORDER AND STIPULATION

CONSENT ORDER

WHEREAS, an Administrative Complaint, hereafter Complaint, was issued on August 16, 2011, charging Ock-Bum Lee, M.D., hereafter Respondent, with having violated section 16221(h) of the Public Health Code, 1978 PA 368, as amended; MCL 333.1101 et seq; and

WHEREAS, Respondent has admitted, by Stipulation submitted herewith, that the facts alleged in the Complaint are true and constitute violations of the Public Health Code; and

WHEREAS, by Stipulation submitted herewith, Respondent has agreed to voluntarily surrender to the Michigan Board of Medicine, hereafter Board, the license to practice medicine previously issued to Respondent by the Board pursuant to the Public Health Code. Respondent further agrees to relinquish any claim to reinstate, renew, or reactivate the license, limited or otherwise at any future date; and

WHEREAS, the Board's Disciplinary Subcommittee has reviewed the Stipulation and, based upon the matters asserted therein, agrees that the public interest is best served by resolution of the outstanding Complaint; now therefore,

IT IS HEREBY FOUND that the allegations of fact and law set forth in the Complaint are true and constitute violations of section 16221(h) of the Public Health Code, supra.

Accordingly,

IT IS HEREBY ORDERED that Respondent's license to practice medicine in the state of Michigan is PERMANENTLY SURRENDERED, commencing on the effective date of this Order.

IT IS FURTHER ORDERED that the surrender of licensure shall be deemed PERMANENT and that said license shall not be renewed, reinstated, reissued or reactivated, limited or otherwise, at any future date.


IT IS FURTHER ORDERED that this Order shall not be modifiable for any cause whatsoever.

STIPULATION

1. The allegations of fact and law contained in the Complaint dated August 16, 2011, are true and constitute violations of section 16221(h) of the Public Health Code, supra.
2. Respondent agrees to permanently surrender to the Board the license to practice medicine previously issued to Respondent pursuant to the Public Health Code.
3. Respondent further agrees to relinquish any claim to reinstate, renew, reissue, or reactivate said license, limited or otherwise, at any future date.
4. Respondent understands and agrees that by permanently surrendering to the Board the license to practice medicine, Respondent's controlled substance license is void and cannot be renewed.

5. Respondent understands and intends that by signing this Stipulation Respondent is waiving the right, pursuant to the Public Health Code, the rules promulgated thereunder, and the Administrative Procedures Act of 1969, 1969 PA 306, as amended; MCL 24.201 et seq., to require the Department of Licensing and Regulatory Affairs, hereafter Department, to prove the charges set forth in the Complaint by presentation of evidence and legal authority, and to appear with an attorney and such witnesses as Respondent may desire to present a defense to said charges.

6. Respondent and the Department agree that this resolution shall be reported by the Department to the National Practitioner Data Bank, and any other entity as required by state or federal law, as a disciplinary sanction. The parties further agree that this Consent Order shall be subject to disclosure as required by the Freedom of Information Act, 1976 PA 442, as amended; MCL 15.231 et seq., and 42 USC 11101-11152.

7. Factors considered in the formulation of the within Consent Order are as follows:

Respondent stated that he has been retired from practice for the past six years and does not plan to return to the practice of medicine. Although the Department presented Respondent with an alternative resolution of a suspension for a minimum period of six months and one day, Respondent opted to surrender his license.


Respondent has been licensed since 1973 and has had no other disciplinary action taken against his license.

8. The foregoing Consent Order is approved as to form and substance by Respondent and the Department and may be entered as the final order of the Board's Disciplinary Subcommittee in said cause.


9. The foregoing proposal is conditioned upon acceptance by the Board's Disciplinary Subcommittee, Respondent and the Department expressly reserving the right to further proceedings without prejudice should the Consent Order be rejected.

ADMINISTRATIVE COMPLAINT

COMPLAINANT, the Michigan Department of Licensing and Regulatory Affairs, by Rae Ramsdell, Acting Director, Bureau of Health Professions, files this Complaint against Respondent, Ock-Bum Lee, M.D., and says:

1. The Michigan Board of Medicine, hereafter Board, is an administrative agency established by the Public Health Code, 1978 PA 368, as amended; MCL 333.1101 et seq. Pursuant to section 16226 of the Public Health Code, supra, the Board's Disciplinary Subcommittee is empowered to discipline licensees for violations of the Public Health Code.

2. Respondent is currently licensed to practice medicine in the state of Michigan and holds a current controlled substance license and has an address of record with Complainant of Hernando, Florida.

3. Respondent failed, upon demand, to submit satisfactory evidence demonstrating that Respondent obtained 150 hours of continuing education credit (with a

minimum of 75 hours in category 1 or category 6) during the period of February 1, 2008, to January 31, 2011, required for license renewal. Respondent submitted no evidence of earning any acceptable continuing education credit during the audit period.

COUNT I

Respondent's conduct, as set forth above, evidences a failure to complete *not less than 150 hours of Board-approved continuing education required for license renewal*, contrary to 1991 AACS, R 338.2371, in violation of section 16221(h) of the Public Health Code, supra.

COUNT II

Respondent's conduct, as set forth above, evidences a failure to complete a minimum of 75 hours of Board-approved continuing education credit in category 1 or category 6 required for license renewal, contrary to 1979 AACS, R 338.2373(1), in violation of section 16221(h) of the Public Health Code, supra.

COUNT III


Respondent's conduct, as set forth above, evidences a failure to submit evidence upon demand demonstrating compliance with continuing education requirements for license renewal, contrary to section 1991 AACS, R 338.2381(2), and section 17033(1) of the Public Health Code, supra, in violation of section 16221(h) of the Public Health Code, supra.

WHEREFORE, Complainant requests that the within Complaint be served upon Respondent and that Respondent be offered an opportunity to show compliance with all lawful requirements for retention of the license. If compliance is not shown, Complainant further requests that formal proceedings be commenced pursuant to the Public Health Code, rules promulgated thereunder, and the Administrative Procedures Act of 1969, 1969 PA 306, as amended; MCL 24.201 et seq.

RESPONDENT IS HEREBY NOTIFIED that pursuant to section 16231(7) of the Public Health Code, supra, Respondent has 30 days from the date of receipt of this Complaint to submit a written response to the allegations contained herein. The written response shall be submitted to Complainant, Rae Ramsdell, Acting Director, Bureau of Health Professions, Department of Licensing and Regulatory Affairs, P.O. Box 30670, Lansing, MI 48909.

RESPONDENT IS FURTHER NOTIFIED that pursuant to section 16231(8) of the Public Health Code, supra, Respondent's failure to submit a written response within 30 days, as noted above, shall be treated as an admission of the allegations contained herein and shall result in transmittal of the Complaint directly to the Board's Disciplinary Subcommittee for imposition of an appropriate sanction.
