## CONSENT ORDER

On August 10, 2016, the Department of Licensing and Regulatory Affairs (Department) executed an <u>Administrative Complaint</u> (Complaint) charging Shumin Zhao, M.D. (Respondent) with violating section(s) 16221(a), 16221(b)(i), 16221(b)(vi), 16221(c)(iv), and 17768(e) of the Public Health Code, MCL 333.1101 et seq.

Respondent neither admits nor denies the facts alleged in the Complaint, but agrees that the Disciplinary Subcommittee of the Michigan Board of Medicine (Disciplinary Subcommittee) shall treat the allegations as true for purposes of this Consent Order and Stipulation (Order) which finding shall have the same force and effect as if evidence and argument were presented in support of the allegations. The Disciplinary Subcommittee has reviewed this Order and agrees that the public interest is best served by resolution of the outstanding Complaint.

Therefore, IT IS FOUND that the facts alleged in the Complaint are true for purposes of this Order and constitute violation(s) of section(s) 16221(a), 16221(b)(i), 16221(c)(iv), and 17768(e) of the Public Health Code, supra.

Accordingly, IT IS ORDERED that for the cited violation(s) of the Public

Health Code, Respondent is REPRIMANDED.

IT IS FURTHER ORDERED that for the cited violation(s) of the Public

Health Code, Respondent is FINED \$2,500.00 to be paid to the State of Michigan within

30 days of the effective date of this Order.

IT IS FURTHER ORDERED that the fine shall be mailed to the Department

of Licensing and Regulatory Affairs, Legal Affairs/Enforcement Division,

Compliance Section, P.O. Box 30189, Lansing, MI 48909. The fine shall be paid by

check or money order, made payable to the State of Michigan, and the check or money

order shall clearly display the file number 43-15-139099.

IT IS FURTHER ORDERED that if Respondent fails to comply with the

terms and conditions of this Order, Respondent's license shall be automatically

suspended for a minimum of one day. If, within six months of the suspension of the

license, Respondent complies with the terms of this Order, the license shall be

automatically reinstated.

IT IS FURTHER ORDERED that if Respondent's license remains

suspended for more than six months, Respondent must apply for reinstatement of the

license. If Respondent applies for reinstatement of the license, application for

reinstatement shall be in accordance with sections 16245 and 16247 of the Public Health

Code, supra.

Subcommittee. Respondent and the Department expressly reserve the right to further

proceedings without prejudice should this Order be rejected.
