ORDER OF UNCONDITIONAL LICENSE

The Minnesota Board of Medical Practice ("Board"), having convened on September 13,

2014, to review the petition of Dr. Stanislav Kruglikov ("Respondent"), for reinstatement of an

unconditional license to practice medicine and surgery makes the following:

FINDINGS OF FACT

1. By Stipulation and Order for Indefinite Suspension dated May 3, 2003 ("2003

Order"), the Board indefinitely suspended Respondent's license to practice medicine based upon

his history of chemical dependency and relapsing to alcohol usage while under monitoring by the

Health Professionals Services Program ("HPSP"). The 2003 Order required Respondent to

refrain from practice until submission of satisfactory evidence to the Board that he was fit and

competent to resume the practice of medicine with reasonable skill and safety to patients.

2. By Stipulation and Order dated July 9, 2005 ("2005 Order"), the Board rescinded

the 2003 Order and reinstated Respondent's license under conditions and restrictions that

required, in part, that Respondent abstain from alcohol and all mood-altering chemicals, attend

self-help program meetings, and submit to unannounced biological fluid screens on a periodic

basis.

3. By Stipulation and Order dated November 8, 2008 ("2008 Order"), Respondent

was reprimanded following his relapse to alcohol usage in violation of his 2005 Order. Under

the terms of the 2008 Order, Respondent was required, in part, to abstain from alcohol and all mood-altering chemicals, attend self-help program meetings, and submit to unannounced biological fluid screens on a periodic basis.

- 4. By Stipulation and Order dated September 11, 2010 ("2010 Order"), Respondent was reprimanded following his use of chemicals in violation of his 2008 Order. Under the terms of the 2010 Order, Respondent's license was suspended, but the suspension was stayed contingent upon Respondent's compliance with terms and conditions which required, in part, that Respondent abstain from alcohol and all mood-altering chemicals, obtain a primary care treating physician to monitor and/or manage all medical or other care provided to Respondent by all health professionals and submit quarterly reports to the Board, attend self-help program meetings at least three times per week, limit his practice to no more than 42 hours per week, and submit to unannounced biological fluid screens at least 18 times per quarter.
- 5. By Committee Order dated May 23, 2011, Respondent's attendance at required self-help program meetings was reduced from three to two meetings per week, and the minimum number of required biological fluid screens was decreased from 18 to 12 screens per quarter.
- 6. By Second Committee Order dated August 23, 2011, Respondent's maximum number of work hours per week was increased from 42 hours to 45 hours.
- 7. By Third Committee Order dated February 19, 2013, the frequency of reports from Respondent's primary care treating physician was reduced from quarterly to semi-annually, the minimum number of required self-help program meetings was decreased from two to one meeting per week, and the minimum number of required biological fluid screens was decreased from 12 to nine screens per quarter.

- 8. By Fourth Committee Order dated October 15, 2013, the minimum number of Respondent's required biological fluid screens was reduced from nine to six screens per quarter and the limitation on Respondent's maximum number of work hours was eliminated.
- 9. On or about June 15, 2014, the Board received a written petition from Respondent requesting consideration of an unconditional license.
- 10. The Board has received reports from HPSP regarding Respondent's compliance with his HPSP monitoring plan, including periodic reports from his primary care treating physician, psychiatrist, therapist, work quality assessor, self-help program sponsor, and designated Board member; and the results of his periodic biological fluid tests. The reports and test results support the conclusion that Respondent has successfully maintained at least five years of documented, uninterrupted recovery.
- 11. On August 11, 2014, the Complaint Review Committee met to discuss Respondent's petition for reinstatement of an unconditional license. The Committee concluded that Respondent had complied with the terms and conditions imposed on his license and recommended that the Board issue an unconditional license to practice medicine and surgery in the State of Minnesota.
- 12. Based on the foregoing, the Board concludes that Respondent has complied with and fulfilled the terms of the Stipulation and Order issued by the Board on September 11, 2010, the Committee Order dated May 23, 2011, the Second Committee Order dated August 23, 2011, the Third Committee Order dated February 19, 2013, and the Fourth Committee Order dated October 15, 2013, and the Board hereby issues the following:

## **ORDER**

IT IS HEREBY ORDERED that an unconditional license to practice medicine and surgery in the State of Minnesota be conferred upon Respondent, such license to carry all duties, benefits, responsibilities, and privileges inherent therein through Minnesota statute and rule.
