This matter is before the North Carolina Medical Board ("Board") on information regarding Hany Aziz Kaoud, M.D. ("Dr. Kaoud"). Dr. Kaoud admits and the Board finds and concludes that:

Whereas the Board is a body duly organized under the laws of North Carolina and is the proper party to bring this proceeding under the authority granted it in Article 1 of Chapter 90 of the North Carolina General Statutes and the rules and regulations promulgated thereto; and

Whereas, on or about September 3, 2009, the Board issued a license to Dr. Kaoud to practice medicine, license number 2009-01680; and

Whereas, during the time relevant herein, Dr. Kaoud practiced medicine in Goldsboro, North Carolina; and

Whereas, in April of 2012, the Board received information that Dr. Kaoud may be diverting medications for his personal use; and

Whereas, prior to the Board's receipt of information regarding Dr. Kaoud, in March 2012, Dr. Kaoud had met with North Carolina Physicians Health Program ("NCPHP") and entered into inpatient treatment at Pavillon; and

Whereas, from on or about November 2010 to February 2012, Dr. Kaoud obtained prescription medications for himself by writing prescriptions for Ultram (tramadol) and Ambien (zolpidem tartrate) in the names of relatives and diverting the medications to himself; and

Whereas, in January 2006, the Board had cautioned Dr. Kaoud for prescribing to colleagues, as well as himself, without performing physical examinations and without documenting the prescriptions in medical records; and

Whereas Dr. Kaoud has not practiced medicine since March 20, 2012; and

Whereas, on June 10, 2012, Dr. Kaoud successfully completed a 90-day in-patient residential treatment program at the Pavillon in North Carolina; and

Whereas Dr. Kaoud's diversion of medication for personal use, as described above, constitutes unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6), and grounds exist for the Board to suspend, revoke or limit Dr. Kaoud's

medical license or to deny any application he might make in the future; and

Whereas Dr. Kaoud acknowledges and agrees that the Board has jurisdiction over him and over the subject matter of this case; and

Whereas Dr. Kaoud knowingly waives his right to any hearing and to any judicial review or appeal in this case; and

Whereas Dr. Kaoud acknowledges that he has read and understands this Consent Order and enters into it voluntarily; and

Whereas Dr. Kaoud would like to resolve this matter without the need for more formal proceedings; and

Whereas the Board has determined that it is in the public interest to resolve this case as set forth below;

Now, therefore, with Dr. Kaoud's consent, it is ORDERED that:

1. Dr. Kaoud's license to practice medicine in North Carolina is hereby INDEFINITELY SUSPENDED.

2. Dr. Kaoud shall meet with the Board or members of the Board for an investigative interview in November of 2012, and at all other times as requested by the Board.

3. Dr. Kaoud shall maintain his contract with NCPHP and abide by all its terms, including the timely payment of fees required by NCPHP.

4. Dr. Kaoud shall obey all laws. Likewise, he shall obey all rules or regulations involving the practice of medicine.

5. Dr. Kaoud shall notify the Board in writing of any change in his residence or practice addresses within ten (10) days of the change.

6. If Dr. Kaoud fails to comply with any of the terms of this Consent Order, that failure shall constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6) and shall be grounds, after any required notice and hearing, for the Board to annul, suspend, revoke, condition, or limit Dr. Kaoud's license to practice medicine or to deny any application he might make in the future or then have pending for a license.

7. This Consent Order shall take effect immediately upon its execution by both Dr. Kaoud and the Board and it shall continue in effect until specifically ordered otherwise by the Board.

8. Dr. Kaoud hereby waives any requirement under any law or rule that this Consent Order be served on him.



This matter is before the North Carolina Medical Board ("Board") to amend the Consent Order between Hany Aziz Kaoud, M.D. ("Dr. Kaoud") and the Board dated August 22, 2012. Dr. Kaoud admits, and the Board finds and concludes that:

STATUTORY AUTHORITY

The Board is a body duly organized under the laws of North Carolina and is the proper party to bring this proceeding under the authority granted it in Article 1 of Chapter 90 of the North Carolina General Statutes; and

FACTUAL FINDINGS

On or about September 3, 2009, the Board issued a license to Dr. Kaoud to practice medicine, license number 2009-01680; and

During the time relevant herein, Dr. Kaoud practiced medicine in Goldsboro, North Carolina; and

In April of 2012, the Board received information that Dr. Kaoud may have been diverting medications for his personal use; and

Prior to the Board's receipt of information regarding Dr. Kaoud, in March 2012, Dr. Kaoud had met with North Carolina Physicians Health Program ("NCPHP") and entered into inpatient treatment at Pavillon; and

From November 2010 to February 2012, Dr. Kaoud obtained prescription medications for himself by writing prescriptions for Ultram (tramadol) and Ambien (zolpidem tartrate) in the names of relatives and diverting the medications to himself; and

Previously, in January 2006, the Board had cautioned Dr. Kaoud, who was practicing under a residency training license at the time, for prescribing to colleagues, as well as himself, without performing physical examinations and without documenting the prescriptions in medical records; and

Dr. Kaoud has not practiced medicine since March 20, 2012; and

On June 10, 2012, Dr. Kaoud successfully completed a 90-day in-patient residential treatment program at the Pavillon in North Carolina; and

Dr. Kaoud and the Board entered into a Consent Order dated August 22, 2012, whereby Dr. Kaoud's license to practice medicine was indefinitely suspended; and

Dr. Kaoud presented to the North Carolina Medical Board for an interview on November 15, 2012; and

The Board and Dr. Kaoud now agree to amend the Consent Order; and

PROCEDURAL STIPULATIONS

Dr. Kaoud acknowledges and agrees that the Board has jurisdiction over him and over the subject matter of this case; and

Dr. Kaoud knowingly waives his right to any hearing and to any judicial review or appeal in this case; and

Dr. Kaoud acknowledges that he has read and understands this Consent Order and enters into it voluntarily; and

Dr. Kaoud would like to resolve this matter without the need for more formal proceedings; and

AMENDED TERMS

Now, therefore, with Dr. Kaoud's consent, it is ORDERED that:

1. Dr. Kaoud shall be issued a temporary license to practice medicine in North Carolina set to expire May 31, 2013.

2. Dr. Kaoud shall meet with the Board or members of the Board for an investigative interview in May 2013, and at all other times as requested by the Board.

3. Dr. Kaoud shall maintain his contract with NCPHP and abide by all its terms, including the timely payment of fees required by NCPHP.

4. Dr. Kaoud shall obey all laws. Likewise, he shall obey all rules or regulations involving the practice of medicine.

5. Dr. Kaoud shall notify the Board in writing of any change in his residence or practice addresses within ten (10) days of the change.

6. If Dr. Kaoud fails to comply with any of the terms of this Amended Consent Order, that failure shall constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6) and shall be grounds, after any required notice and hearing, for the Board to annul, suspend, revoke, condition, or limit Dr. Kaoud's license to practice medicine or to deny any application he might make in the future or then have pending for a license.

7. This Amended Consent Order shall take effect immediately upon its execution by both Dr. Kaoud and the Board

and it shall continue in effect until specifically ordered otherwise by the Board.

8. Dr. Kaoud hereby waives any requirement under any law or rule that this Amended Consent Order be served on him.





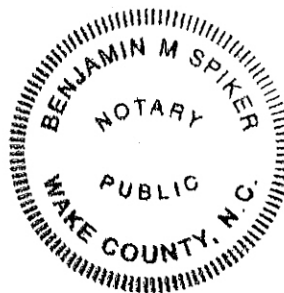
