I hereby surrender my license to practice medicine issued by the Board effective upon receipt of this document by the Board or its agent.

I understand that I may not give medical advice or treatment to any person, with or without compensation; may not prescribe drugs; and may not otherwise engage in the practice of medicine within the meaning of N.C. Gen. Stat. §90-18. Once tendered, this decision to surrender my license may not be withdrawn. I understand that the surrender of my license does not preclude the Board from bringing charges against me at a later date.

I understand that I have obligations to patients that continue beyond the surrender of my license including, but not limited to, winding up my practice in an orderly fashion, assisting patients in ensuring continuity of their care, and preserving patient records and access thereto.

I understand that this document is a public document within the meaning of Chapter 132 of the North Carolina General Statutes and shall be subject to public inspection and dissemination pursuant to the provisions thereof. Additionally, it may be reported to persons, entities, agencies, and clearinghouses as required by and permitted by law including, but not limited to, the Federation of State Medical Boards, the National Practitioner's Data Bank, and the Healthcare Integrity and Protection Data Bank.

I understand my right to and I have been given the opportunity to consult with an attorney, at my own expense, before tendering this surrender of my license. I have made the decision to surrender my license to practice medicine knowingly, voluntarily, and of my own free will.

I agree to return my license and registration certificates to the Board as promptly as possible. Any failure on my part to do so does not in any way affect the validity of this surrender of my license.

This matter is before the North Carolina Medical Board
~~(hereafter "Board") on the self-report of Roy Dewayne Book, M.D.~~
(hereafter "Dr. Book"). Dr. Book admits, and the Board finds
and concludes, that:

Whereas, the Board is a body duly organized under the laws
of North Carolina and is the proper party to bring this
proceeding under the authority granted it in Article 1 of
Chapter 90 of the North Carolina General Statutes, and

Whereas, on or about November 22, 1997, the Board first
issued a license to practice medicine and surgery to Dr. Book,
license number 97-01700, and

~~Whereas, during the times relevant herein, Dr. Book~~
practiced medicine in Greensboro, North Carolina, and

Whereas, Dr. Book self-reported to the Board that he has
been arrested for driving under the influence once in 2008 and
again in 2009, and

Whereas, as a result of the most recent incident, Dr. Book submitted himself to treatment for alcohol dependence at a residential treatment facility, and

Whereas, when drinking alcohol, Dr. Book is unable to safely practice medicine by reason of excessive use of alcohol within the meaning of N.C. Gen. Stat. § 90-14(a)(5), and grounds exist under that section of the North Carolina General Statutes for the Board to annul, suspend, revoke, or limit his license to practice medicine and surgery issued by the Board or deny any application he might make in the future, and

Whereas Dr. Book is a participant in the North Carolina Physicians Health Program, and

Whereas Dr. Book would like to resolve this matter without the need for more formal proceedings, and

Whereas the Board has determined that it is in the public interest to resolve this case as set forth below;

Now, therefore, with Dr. Book's consent, it is ORDERED that:

1. Dr. Book's North Carolina medical license is hereby SUSPENDED INDEFINITELY.

2. Dr. Book shall obey all laws. Likewise, he shall obey all rules and regulations involving the practice of medicine.

3. Dr. Book shall notify the Board in writing of any change in his residence or practice addresses within ten (10) days of the change.

4. If Dr. Book fails to comply with any of the terms of this Consent Order, that failure shall constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6) and shall be grounds, after any required notice and hearing, for the Board to annul, suspend, or revoke his license to practice medicine and surgery and to deny any application he might make in the future or then have pending for a license.

6. This Consent Order shall take effect immediately upon its execution by both Dr. Book and the Board, and it shall continue in effect until specifically ordered otherwise by the Board.

7. Dr. Book hereby waives any requirement under law or rule that this Consent Order be served on him.

8. Upon execution by Dr. Book and the Board, this Consent Order shall become a public record within the meaning of Chapter 132 of the North Carolina General Statutes and shall be subject to public inspection and dissemination pursuant to the provisions thereof. Additionally, it will be reported to persons, entities, agencies, and clearinghouses as required by and permitted by law including, but not limited to, the

Federation of State Medical Boards, the National Practitioner Data Bank, and the Healthcare Integrity and Protection Data Bank.

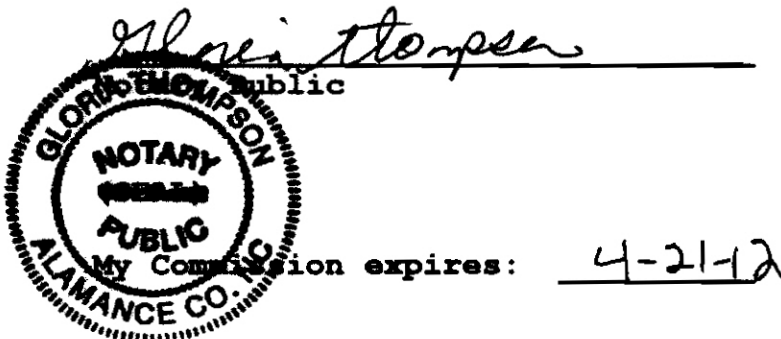

This matter is before the North Carolina Medical Board ("Board") on the application of Roy Dewayne Book, M.D. ("Dr. Book") for reinstatement of his license to practice medicine previously issued by the Board. Dr. Book admits, and the Board finds and concludes, that:

Whereas the Board is a body duly organized under the laws of North Carolina and is the proper party to consider this matter under the authority granted it in Article 1 of Chapter 90 of the North Carolina General Statutes; and

Whereas the Board first issued Dr. Book a license to practice medicine on November 22, 1997, license number 9701770; and

Whereas, during the time relevant herein, Dr. Book practiced medicine in Greensboro, North Carolina; and

Whereas Dr. Book has a history of alcohol abuse; and

Whereas Dr. Book surrendered his North Carolina medical license on May 1, 2009; and

Whereas Dr. Book subsequently entered into a Consent Order on August 31, 2009, which indefinitely suspended his North Carolina medical license; and

Whereas Dr. Book successfully completed an in-patient treatment program for his alcohol abuse; and

Whereas Dr. Book has entered into a contract with the North Carolina Physicians Health Program ("NCPHP"); and

Whereas NCPHP reports that Dr. Book has been compliant with his NCPHP contract; and

Whereas Dr. Book met with members of the Board on March 17, 2011, to discuss the above; and

Whereas Dr. Book has taken steps and has agreed to take further steps to ensure the Board and the people of North Carolina that he will be able to safely practice medicine; and

Whereas, Dr. Book has met with a Board Member to discuss his application, including the need for a program of reentry to ensure his safe transition back into the active, independent practice of medicine;

Now, therefore, with Dr. Book's consent, it is ORDERED that:

1. The Board shall reissue Dr. Book's license to practice medicine to expire on the date shown thereon.

2. Dr. Book shall abide by the following terms during his reentry into the practice of medicine:

a. For a period of four and one half months ("Reentry Period"), Dr. Book will provide patient care under the supervision of a preceptor. Prior to beginning the Reentry Period, Dr. Book will ensure that his preceptor has been approved by the Office of the Medical Director of the North Carolina Medical Board. The goal of the supervised patient care is to re-introduce Dr. Book to independent and unsupervised patient care.

b. Dr. Book will be responsible for seeing the patient, taking the history, performing a physical examination, establishing a differential diagnosis and treatment plan, and completing chart documentation. Dr. Book's preceptor will monitor the care rendered through focused chart reviews of all new patients, higher acuity patients, and random chart audits with a minimum of twenty-five percent (25%) of charts reviewed. Patients new to the practice and high acuity patients will be discussed with Dr. Book's preceptor prior to patient discharge. Record review as described above will occur at the end of every practice day.

c. At the end of every other week, Dr. Book's preceptor and Dr. Book will meet for a minimum of one hour to discuss patients of interest, opportunities for improvement, Dr. Book's focused CME, Dr. Book's medical

record documentation, and other items as appropriate.

d. If Dr. Book performs any procedures, he will keep a log of all procedures completed, and Dr. Book's preceptor will supervise all procedures until he or she confirms that Dr. Book has performed the procedure competently. Dr. Book's preceptor will sign the procedure log when he or she confirms Dr. Book's competency for the procedure.

e. During the Reentry Period, Dr. Book may not practice medicine or surgery outside of the scope of this Consent Order and the provisions related to the Reentry Period until he has received written confirmation from the Board that he has satisfactorily completed all requirements for this Reentry Period.

f. Upon completion of this Reentry Period, Dr. Book's preceptor will provide the Board with a summary approval letter indicating whether Dr. Book satisfactorily completed the Reentry Period and assessing Dr. Book's ability and competence to practice independent, unsupervised patient care. This letter will provide the Board with a detailed summary and final report of Dr. Book's progress, including an assessment of Dr. Book's ability to take a patient history, perform a physical examination, establish a differential diagnosis

and treatment plan, and complete chart documentation. The summary report will include a description of Dr. Book's clinical judgement and reasoning, and his proficiency at any procedures he performs. The summary report will provide the number of patients seen by Dr. Book during the reentry period, and will include each patient's diagnoses for which Dr. Book provided care. If Dr. Book provides care to any patients who have been admitted to the hospital, these patients will be identified in the preceptor's summary letter. Dr. Book's remediation activities, including focused CME and practice-based learning, will be described, and a brief account of topics discussed during each meeting between Dr. Book and his preceptor will be included.

3. Dr. Book shall maintain a contract with NCPHP and abide by its terms, including the timely payment of any fees required by NCPHP.

4. Unless lawfully prescribed for Dr. Book by someone other than himself, Dr. Book shall refrain from the use or possession of alcohol and all other mind- or mood-altering substances and all controlled substances including but not limited to, sedatives, stimulants, and pain medication.

5. Upon request by the Board, Dr. Book shall supply urine, blood, hair, or any other bodily fluid or tissue sample the Board

might reasonably require for the purposes of analysis to determine if he has consumed any of the substances mentioned above. All costs of obtaining and analyzing such samples shall be borne by Dr. Book.

6. Dr. Book shall meet with the Board or members of the Board for an informal interview at the Board's September 2011 meeting and at any other times requested by the Board.

7. Dr. Book shall obey all laws. Likewise, he shall obey all rules or regulations involving the practice of medicine.

8. Dr. Book shall notify the Board in writing of any change in his residence or practice addresses within ten (10) days of the change.

9. If Dr. Book fails to comply with any of the terms of this Consent Order, that failure shall constitute unprofessional conduct within the meaning of N.C. Gen. Stat. § 90-14(a)(6) and shall be grounds, after any required notice and hearing, for the Board to annul, suspend, or revoke his license to practice medicine and surgery and to deny any application he might make in the future or then have pending for a license.


