Whereas, Respondent has surrendered her license and the Board has issued her a temporary license limited to her practice at Dorothea Dix Hospital; and

Whereas, Respondent has enrolled in the North Carolina Physicians Health and Effectiveness Program ("NCPHEP"); and

Whereas, grounds exist under North Carolina General Statutes section 90-14(a)(5) for revocation of the license to practice medicine in the State of North Carolina previously issued to Respondent by the Board; and

Whereas, Respondent is prepared to undertake the actions set forth hereinafter; and

Whereas, Respondent wishes to resolve this matter without need for formal proceedings; and

Whereas, the Board has determined it to be in the public interest to resolve this matter as hereinafter set forth.

Now, therefore, with the consent of Respondent freely given, it is ORDERED that:

1. Respondent shall abide by the terms of her NCPHEP contract.

2. Respondent shall meet with the Board at its January 1991 meeting and at such times as requested to appear by the Board.

3. Respondent shall cooperate with the Board and its representatives in such monitoring of Respondent's practice as the Board may deem reasonably necessary.


4. The failure to Respondent to comply with any of the provisions of this Consent Order shall be, after proper notice and hearing, grounds for disciplinary action by the Board against Respondent including, without limitation, revocation of license.




