MAJOR WILLIAM N. KING, [REDACTED] United States Air Force, 55th Medical Operations Squadron, was arraigned at Offutt AFB, Nebraska, on the following offenses at a court-martial convened by this headquarters.

CHARGE I: Article 92. Plea: NG. Finding: G.

Specification: Who knew of his duties at or near Offutt Air Force Base, Nebraska, between on or about 1 November 2015 and on or about 31 March 2016, was derelict in the performance of those duties in that he willfully failed to refrain from seeking [REDACTED] sexual activity with [REDACTED] a patient who was receiving his psychological services and treatment, as it was his duty to do. Plea: NG. Finding: G, except the words [REDACTED] Of the excepted words: NG.

CHARGE II: Article 134. Plea NG. Finding: G

Specification: Did, at or near Offutt Air Force Base, Nebraska, between on or about 1 November 2015 and on or about 30 March 2016, knowingly fraternize with [REDACTED] an enlisted person, on terms of military equality, to wit: [REDACTED] sending [REDACTED] messages of a sexual nature [REDACTED]

[REDACTED] in violation of the custom of the United States Air Force that officers shall not fraternize with enlisted persons on terms of military equality, such conduct being to the prejudice of good order and discipline in the armed forces. Plea: NG. Finding: G, except the words [REDACTED]

SENTENCE

Sentence adjudged by officer members on 11 November 2018: Dismissal.
