Dear Doctor Shlewiet:

In accordance with Chapter 119., Ohio Revised Code, you are hereby notified that the State Medical Board of Ohio [Board] intends to determine whether or not to limit, revoke, permanently revoke, or suspend your license or certificate, or refuse to grant or register or issue the license/certificate for which you have a pending application in accordance with Section 9.79 of the Ohio Revised Code, or refuse to renew or reinstate your license or certificate to practice medicine and surgery, or to reprimand you or place you on probation for one or more of the following reasons:

(1) In or around September 2016, you entered into a Consent Agreement and Order with the Commonwealth of Pennsylvania, Department of State, Bureau of Professional and Occupational Affairs, whereby you agreed to permanently surrender your license to practice as a medical physician and surgeon in Pennsylvania, and on or about October 18, 2016, the Pennsylvania Board of Medicine issued an Order whereby it adopted and approved the aforementioned Consent Agreement [October 2016 Pennsylvania Board Order]. The October 2016 Pennsylvania Board Order, a copy of which is attached and incorporated herein, related to your conviction of multiple criminal offenses, which included "unlawful contact with a minor – sexual offenses," for which you were sentenced to a minimum of seven years and a maximum of seventeen years imprisonment. These were felony and misdemeanor offenses that occurred during the course of your practice.

The October 2016 Pennsylvania Board Order as alleged in paragraph (1) above, constitutes "[a]ny of the following actions taken by an agency responsible for authorizing, certifying, or regulating an individual to practice a health care occupation or provide health care services in this state or another jurisdiction, for any reason other than the nonpayment of fees: the limitation, revocation, or suspension of an individual's license to practice; acceptance of an individual's license surrender; denial of a license; refusal to renew or reinstate a license; imposition of probation; or issuance of an order of censure or other reprimand," as that clause is used in Section 4731.22(B)(22), Ohio Revised Code.

Furthermore, for any violations that occurred on or after September 29, 2015, the board may impose a civil penalty in an amount that shall not exceed twenty thousand dollars, pursuant to Section 4731.225, Ohio Revised Code. The civil penalty may be in addition to any other action the board may take under section 4731.22, Ohio Revised Code.

Pursuant to Chapter 119., Ohio Revised Code, you are hereby advised that you are entitled to a hearing in this matter. If you wish to request such hearing, the request must be made in writing and

must be received in the offices of the State Medical Board within thirty days of the time of mailing of this notice.

You are further advised that, if you timely request a hearing, you are entitled to appear at such hearing in person, or by your attorney, or by such other representative as is permitted to practice before this agency, or you may present your position, arguments, or contentions in writing, and that at the hearing you may present evidence and examine witnesses appearing for or against you.

In the event that there is no request for such hearing received within thirty days of the time of mailing of this notice, the State Medical Board may, in your absence and upon consideration of this matter, determine whether or not to limit, revoke, permanently revoke, or suspend your license or certificate, or refuse to grant or register or issue the license/certificate for which you have a pending application in accordance with Section 9.79 of the Ohio Revised Code, or refuse to renew or reinstate your license or certificate to practice medicine and surgery, or to reprimand you or place you on probation.

Please note that, whether or not you request a hearing, Section 4731.22(L), Ohio Revised Code, provides that "[w]hen the board refuses to grant or issue a license or certificate to practice to an applicant, revokes an individual's license or certificate to practice, refuses to renew an individual's license or certificate to practice, or refuses to reinstate an individual's license or certificate to practice, the board may specify that its action is permanent. An individual subject to a permanent action taken by the board is forever thereafter ineligible to hold a license or certificate to practice and the board shall not accept an application for reinstatement of the license or certificate or for issuance of a new license or certificate."

CONSENT AGREEMENT AND ORDER

PARTIES

The Commonwealth of Pennsylvania, Department of State, Bureau of Professional and Occupational Affairs ("Commonwealth") and Basem Kaleem Shlewiet, M.D. ("Respondent") stipulate as follows in settlement of the above-captioned case.

APPLICABLE LAW

1. This matter is before the State Board of Medicine ("Board") pursuant to Medical Practice Act, Act of December 20, 1985, P.L. 457, No. 112, ("Act"), as amended, 63 P.S. §§ 422.1-422.53; the Medical Care Availability and Reduction of Error ("MCARE") Act, Act of March 20, 2002, P.L. 154, No. 13, as amended, 40 P.S. §§ 1303.101-1303.910; the Criminal History Record Information Act, Act of July 16, 1979, P.L. 116, No. 47 ("CHRIA"), as amended, 18 Pa. C.S. §§ 9101 – 9183; and/or the Act of July 2, 1993, P.L. 345, No. 48 ("ACT 48"), as amended, 63 P.S. §§ 2201-2207.

LICENSURE STATUS

2. At all relevant and material times, Respondent held a license to practice as a medical physician and surgeon in the Commonwealth of Pennsylvania, license no. MD073753L, which was originally issued on July 3, 2001, and which expired on December 31, 2014.

- 3. By Order dated January 23, 2014, an Immediate Temporary Suspension was imposed upon the Respondent's license to practice as a medical physician and surgeon in the Commonwealth of Pennsylvania.
- 4. By Order dated March 19, 2014, the Respondent voluntarily surrendered his license to practice as a medical physician and surgeon in the Commonwealth of Pennsylvania, pending the outcome of the criminal matter at issue.
- 5. At all times pertinent to the Factual Allegations, Respondent held, and continues to hold, a property interest in a license to practice as a medical physician and surgeon in the Commonwealth of Pennsylvania.

STIPULATED FACTS

- 6. The Respondent, while admitting no guilt or wrongdoing, agrees that if this case were to proceed to a hearing the Commonwealth would be able to prove the following:
 - a. Absent further action by the Board, the Respondent's license may be renewed, reactivated or reinstated upon the filing of the appropriate documentation and payment of the necessary fees.
 - b. Respondent's last known address on file with the Board is 16 North
 Franklin Street, Suite 100, Doylestown, PA 18901.
 - c. Respondent's current address is SCI-Houtzdale, P.O. Box 1000, Houtzdale, PA 16698-1000.
 - d. On or about March 20, 2014 the Respondent was charged with multple criminal counts in the Court of Common Pleas of Bucks County at docket number CP-09-CR-0001645-2014 and CP-09-CR-0001646-2014, which included the following:

- (1) Unlawful Contact with a Minor-Sexual Offenses,
- 18 Pa. C.S.A. § 6318(a)(1), a Felony of the Third Degree,
- (2) <u>Corruption of Minors</u>, 18 Pa. C.S.A. § 6301 (a)(1)(i), a Misdemeanor of the First Degree,
- (3) Indecent Assault Forcible Compulsion, 18 Pa.
- C.S.A. § 3126(a)(2), a Misdemeanor of the First Degree, and
- (4) Indecent Assault without Consent of Other, 18
 Pa. C.S.A. § 3126(a)(1),
- (5) <u>Indecent Assault</u>, a Misdemeanor of the Second Degree.
- e. On or about October 14, 2014, following a jury trial, the Respondent was found guilty on multiple criminal counts, which included the following:
 - (1) Unlawful Contact with a Minor-Sexual Offenses, 18 Pa. C.S.A. § 6318(a)(1), a Felony of the Third Degree,
 - (2) <u>Corruption of Minors</u>, 18 Pa. C.S.A. § 6301 (a)(1)(i), a Misdemeanor of the First Degree,
 - (3) Indecent Assault Forcible Compulsion, 18 Pa.
 - C.S.A. § 3126(a)(2), a Misdemeanor of the First Degree, and
 - (4) <u>Indecent Assault without Consent of Other</u>, 18
 Pa. C.S.A. § 3126(a)(1),
 - (5) <u>Indecent Assault</u>, a Misdemeanor of the Second Degree.

- f. On or about February 9, 2015, the Respondent was sentenced by the Court of Common Pleas of Bucks County to a minimum of 7 years and a maximum of 17 years imprisonment in a state correctional facility.
- g. True and correct copies of the Affidavit of Probable Cause, Criminal Complaint, Criminal Information, Criminal Indictment, Verdict of Guilt, Docket Report and Sentencing Sheet are attached collectively as **EXHIBIT A** and are incorporated by reference.
- h. The aforementioned criminal charges arise, at least in part, from the Respondent's conduct during the course of treating patients in the practice of medicine and surgery in the Commonwealth of Pennsylvania.

ALLEGED VIOLATIONS

- 7. The Commonwealth alleges that the Board is authorized to:
- a. Suspend, revoke, or otherwise restrict Respondent's license under Sections 41 and 42 of the Act, 63 P.S. §§ 422.41 & 422.42; and/or impose a civil penalty upon Respondent under Sections 39 through 42 of the Act, 63 P.S. §§ 422.39-422.42, and /or Section 5(b)(4) of ACT 48, 63 P.S. § 2205(b)(4); and/or impose the costs of investigation upon Respondent under Section 5(b)(5) of ACT 48, 63 P.S. § 2205(b)(5), because Respondent was convicted, as defined by the Act, of a felony and/or a misdemeanor relating to a health profession in the courts of this Commonwealth, in violation of Section 41(3) of the Act, 63 P.S. § 422.41(3),
- b. Suspend or revoke Respondent's license under Section 9124(c)(1) of CHRIA, 18 Pa. C.S.A. § 9124(c)(1), because Respondent has been convicted of any felony,

c. Suspend or revoke Respondent's license under Section 9124(c)(2) of CHRIA, 18 Pa. C.S.A. § 9124(c)(2), because Respondent has been convicted of any misdemeanor related to the practice of the profession.

PROPOSED ORDER

- 8. The parties, intending to be legally bound, consent to the issuance of the following Order in settlement of this matter:
 - a. The Board finds that it is authorized to:
 - (1) Suspend, revoke, or otherwise restrict Respondent's license under Sections 41 and 42 of the Act, 63 P.S. §§ 422.41 & 422.42; and/or impose a civil penalty upon Respondent under Sections 39 through 42 of the Act, 63 P.S. §§ 422.39-422.42, and /or Section 5(b)(4) of ACT 48, 63 P.S. § 2205(b)(4); and/or impose the costs of investigation upon Respondent under Section 5(b)(5) of ACT 48, 63 P.S. § 2205(b)(5), because Respondent was convicted, as defined by the Act, of a felony and/or a misdemeanor relating to a health profession in the courts of this Commonwealth, in violation of Section 41(3) of the Act, 63 P.S. § 422.41(3),
 - (2) Suspend or revoke Respondent's license under Section 9124(c)(1) of CHRIA, 18 Pa. C.S.A. § 9124(c)(1), because Respondent has been convicted of any felony,
 - (3) Suspend or revoke Respondent's license under Section 9124(c)(2) of CHRIA, 18 Pa. C.S.A. § 9124(c)(2), because Respondent has been convicted of any misdemeanor related to the practice of the profession.

PERMANENT VOLUNTARY SURRENDER

b. In consideration for not imposing other disciplinary sanctions (which could include the revocation of Respondent's license to practice as a medical physician and surgeon and the imposition of civil penalties and/or the costs of investigation), the Parties propose, and the Board hereby accepts, the PERMANENT VOLUNTARY SURRENDER of Respondent's license to practice as a medical physician and surgeon in the Commonwealth of Pennsylvania, along with any other licenses, registrations, certificates, approvals, authorizations, or permits (hereinafter referred to collectively as "authorizations to practice the profession") issued by the Board to Respondent at the time this Consent Agreement is adopted by the Board. Respondent acknowledges that with the permanent voluntary surrender of his authorizations to practice the profession, Respondent is surrendering any and all property rights he may have in those authorizations to practice the profession and will no longer be eligible to renew those authorizations to practice the profession. As further stated consideration for the Commonwealth not seeking other disciplinary sanctions against Respondent, Respondent agrees to:

(1) cease practicing as a medical physician and surgeon in the Commonwealth on and after the effective date of this Consent Agreement, and shall not indicate any ability to practice the profession in the Commonwealth in any manner whatsoever in the future,

- (2) Unless otherwise specified in this agreement, Respondent agrees to not apply, at any time in the future, for the reactivation, reinstatement, reissuance, or the issuance of any authorization to practice issued by the Board and further directs that the board should not consider, and may deny without hearing, any application for an authorization to practice filed with the Board,
- (3) not work as an unlicensed assistant to any person holding an authorization from the Board to practice the profession,
- (4) not possess a controlling interest in any organization requiring an authorization from the Board to practice the profession,
- (5) not possess a controlling interest in any organization whose employees require an authorization from the Board to practice the profession when conducting the business of the organization,
- c. For purposes of this paragraph, the term 'controlling interest' shall include being an owner, officer, manager, director, partner, member, or associate, as well as owning any quantity of outstanding corporate stock sufficient to control or direct the actions of the firm.

d. The Respondent may seek reinstatement of his license to practice medicine and surgery in the Commonwealth of Pennsylvania only if all of the aforementioned convictions in Paragraph 6 of this Agreement are reversed on appeal and all criminal charges related to said convictions are dismissed. As a prerequisite to any such reinstatement, Respondent shall show to the Board's satisfaction that the aforementioned conviction in Paragraph 6 of this Agreement is reversed on appeal, all criminal charges related to said conviction are dismissed, no criminal charges are currently pending against him, and Respondent must comply with any other requirements of reinstatement imposed by the Board and/or set forth in the Act.

e. Respondent shall, within ten (10) days of adoption of this Consent Agreement and Order, surrender Respondent's wall certificate, biennial renewal certificate and wallet card (or notarized affidavit of their loss or destruction) by mailing them to:

- f. This Order constitutes disciplinary action by the Board and shall be reported to other licensing authorities and any applicable national licensing databank as a disciplinary action by the Board.
- g. This case shall be deemed settled and discontinued upon the Board issuing an Order adopting this Consent Agreement.

ADMISSIBILITY OF CONSENT AGREEMENT IN FUTURE PROCEEDINGS

9. Respondent agrees that if Respondent is charged with a violation of an Act enforced by this Board in the future, this Consent Agreement and Order shall be admitted into evidence without objection in that proceeding.

ACKNOWLEDGMENT OF NOTICE AND WAIVER OF HEARING

10. Respondent acknowledges receipt of an Order to Show Cause in this matter. Respondent knowingly and voluntarily waives the right to an administrative hearing in this matter, and knowingly and voluntarily waives the following rights related to that hearing: to be represented by counsel at the hearing; to present witnesses and testimony in defense or in mitigation of any sanction that may be imposed for a violation; to cross-examine witnesses and to challenge evidence presented by the Commonwealth; to present legal arguments by means of a brief; and to take an appeal from any final adverse decision.

ACKNOWLEDGMENT OF RIGHT TO ATTORNEY

11. Respondent acknowledges that he is aware that he has the right to consult with, and/or be represented by, private legal counsel of Respondent's choosing and at Respondent's expense when reviewing, considering and accepting the terms of this Consent Agreement. To the extent that Respondent is not represented by legal counsel, Respondent has knowingly elected to proceed without the assistance of legal counsel.

WAIVER OF CLAIM OF COMMINGLING AND OTHER CONSTITUTIONAL CLAIMS

12. Respondent expressly waives any constitutional rights and issues, such as commingling of prosecutorial and adjudicative functions by the Board or its counsel, which may arise or have arisen during the negotiation, preparation and/or presentation of this Consent Agreement. Respondent specifically agrees that if the Board rejects this agreement, it may assume that the facts and averments as alleged in this Consent Agreement are true and correct for the limited purpose of recommending a sanction, based on those assumed facts that would be acceptable to the Board before hearing the case. In the event that the Board does assume the facts and averments as alleged in this Consent Agreement are true for purposes of making a recommendation as to an acceptable sanction, such action shall not constitute commingling of prosecutorial and adjudicative functions by the Board or its counsel, and the Respondent expressly waives any constitutional rights and issues related to alleged commingling, bias, or violation of due process rights to have an unbiased and impartial adjudicator in any subsequent hearing. If a hearing is subsequently held, neither this Consent Agreement nor the proposed terms of settlement may be admitted into evidence and any facts, averments, and allegations contained in the Consent Agreement must be proven at hearing unless otherwise separately stipulated. This paragraph is binding on the participants even if the Board does not approve this Consent Agreement.

NO MODIFICATION OF ORDER

13. Respondent agrees, as a condition of entering into this Consent Agreement, not to seek modification at a later date of the Stipulated Order adopting and implementing this Consent Agreement without first obtaining the express written concurrence of the Prosecution Division.

AGREEMENT NOT BINDING ON OTHER PARTIES

14. The Office of General Counsel has approved this Consent Agreement as to form and legality; however, this Consent Agreement shall have no legal effect unless and until the Board issues the stipulated Order.

EFFECT OF BOARD'S REJECTION OF CONSENT AGREEMENT

15. Should the Board not approve this Consent Agreement, presentation to and consideration of this Consent Agreement and other documents and matters by the Board shall not prejudice the Board or any of its members from further participation in the adjudication of this matter. This paragraph is binding on the participants even if the Board does not approve this Consent Agreement.

ENTIRE AGREEMENT

16. This agreement contains the whole agreement between the participants; provided however, that the captions printed in the various provisions of this agreement are for ease of reading only and are not to be interpreted as forming any part of this agreement. There are no other terms, obligations, covenants, representations, statements or conditions, or otherwise, of any kind whatsoever concerning this agreement.

AGREEMENT DOES NOT PREVENT ADDITIONAL DISCIPLINE BASED ON OTHER COMPLAINTS

17. Nothing in this Order shall preclude the Prosecution Division for the Commonwealth from filing charges or the Board from imposing disciplinary or corrective measures for violations or facts not contained in this Consent Agreement;

VERIFICATION OF FACTS AND STATEMENTS

18. Respondent verifies that the facts and statements set forth in this Consent Agreement are true and correct to the best of Respondent's knowledge, information and belief. Respondent understands that statements in this Consent Agreement are made subject to the criminal penalties of 18 Pa.C.S.A. §4904 relating to unsworn falsification to authorities.

Your Honor, your Affiants are Detective Mark Zielinski #9911, Detective Jack Slattery #9923 of the Bucks County District Attorney's Office, and Detective Wayne Jones #195 of the Doylestown Borough Police Department. Detective Zielinski has been a sworn law enforcement officer in the Commonwealth of Pennsylvania for twenty-eight (28) years; the last twenty-four years of which have been spent in the rank of Detective. Detective Slattery has been a sworn law enforcement officer in the Commonwealth of Pennsylvania for ten (10) years; the last five years of which have been spent in the rank of Detective. On Wednesday January 15, 2014, your Affiants Zielinski and Slattery spoke with Commonwealth's Complainant 3, hereafter referred to as CC3, a fourteen (14) year old juvenile female. CC3 advised that she began seeing Doctor Shlewiet since approximately August of 2013. 




