COMPLAINT

COMES NOW the plaintiff, the State of Oklahoma ex rel. the Oklahoma State Board of Medical Licensure and Supervision (the "Board"), by and through its attorney, Elizabeth A. Scott, Assistant Attorney General, and for its Complaint against the Defendant, Stephen Lester Greer, M.D., Oklahoma license no. 17372, alleges and states as follows:

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.*

2. Defendant, Stephen Lester Greer, M.D., holds Oklahoma license no. 17372 and is a practicing psychiatrist in Broken Arrow, Oklahoma.

3. Beginning on or around May 15, 2003 and continuing through February 2004, Patient DHW was a patient of Defendant. During this time, Defendant engaged in physical conduct with Patient DHW which was sexual in nature. Defendant engaged in the sexual conduct in his office, at a motel in Broken Arrow, Oklahoma paid for by Defendant, and in his car. Defendant engaged in these sexual acts at the same time that he was maintaining a doctor-patient relationship and prescribing controlled dangerous substances to this patient.

4. During the time that Defendant was treating Patient DHW and was engaging in physical conduct with Patient DHW which was sexual in nature, Defendant allegedly "employed" Patient DHW in his office. Defendant allowed Patient DHW to work off her bill by copying other psychiatric patients' charts and doing other work around the office. Defendant

6. That Defendant's guilty pleas and/or convictions involving DUIs, including January 27, 1984, in LeFlore County, Oklahoma, 1990 in Red Bluff, California, and December 15, 1993, in Hughes County, Oklahoma, and the Defendant's warning and termination from the Las Vegas, New Mexico, Medical Center, all relate to habitual, excessive use of alcohol and raise questions as to the Defendant's fitness to practice medicine.

CONCLUSIONS OF LAW

1. That Kenneth Foster, M.D., holding Oklahoma Medical License No. 15885, is in violation of the Oklahoma Medical Practice Act, 59 O.S. 1991, Sec. 508, and 59 O.S. Supp. 1993, Sec. 509, Paragraph 9, to-wit:

"Whenever any license or certificate has been procured or obtained by fraud or misrepresentation...it shall be the duty of the State Board of Medical Licensure and Supervision to revoke such license or certificate in the same manner as is provided by this Act for the revocation of license or certificate for unprofessional conduct."

"9. Dishonorable or immoral conduct which is likely to deceive or defraud the public."

ORDER

IT IS THEREFORE ORDERED by the Oklahoma Board of Medical Licensure and Supervision as follows:

1. That the Oklahoma Medical License No. 15885 of Defendant, Kenneth Foster, M.D., should be and the same is hereby REVOKED.

2. That a copy of this written Order should be sent to the Defendant and/or his legal counsel as soon as it is processed.



ORDER GRANTING SPECIAL LICENSE
EFFECTIVE AT FUTURE DATE

This cause came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on June 16, 1994, at the office of the Oklahoma State Board of Medical Licensure and Supervision, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and the rules of the Board.

Daniel J. Gamino, Attorney, appeared for the Plaintiff; and Kenneth Foster, former holder of Oklahoma Medical License No. 15885, Defendant, appeared in person and by and through legal counsel, Kevin J. Walker, Attorney at Law, P.O. Box 1641, Seminole, OK 74868, and Gene Stipe, Attorney at Law, P.O. Box 1368, McAlester, OK 74502.

That the Oklahoma Board of Medical Licensure and Supervision en banc heard testimony, reviewed exhibits and being fully advised in the premises, the Oklahoma Board finds and orders as follows:

FINDINGS OF FACT

1. That Defendant, Kenneth Foster, formerly held Oklahoma Medical License No. 15885.

2. That the Oklahoma Board of Medical Licensure and Supervision en banc has jurisdiction over the subject matter herein and that notice has been given in all respects as required by law and the rules of the Board.


3. That following notice and hearing on March 18, 1994, the Board revoked Defendant's Oklahoma Medical License No. 15885.

4. That the Oklahoma Legislature in May, 1994, did enact the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, 59 O.S. Supp. 1994, Sec. 480 et seq. That a portion of that new legislation establishes special licensure wherein the Board may authorize the issuance of conditional, restricted or otherwise circumscribed license as necessary to protect public health, safety and welfare.

5. That evidence indicated that there was a need for the Defendant to provide psychiatric services for the Oklahoma Department of Corrections at the Special Care Unit at the Maximum Security Prison in McAlester, Oklahoma, and to perform evaluations at the Carl Albert Mental Health Center, McAlester, Oklahoma. There was danger that in the event the Department of Corrections did not obtain psychiatric coverage for the Special Care Unit, that program would be lost. And evidence indicated

APPLICATION TO DETERMINE EMERGENCY

Plaintiff, the State of Oklahoma ex rel. the Oklahoma State Board of Medical Licensure and Supervision ("State"), seeks to have an emergency declared to enable the Secretary of the Board to conduct an emergency suspension hearing against Defendant, Stephen Lester Greer, M.D., Oklahoma medical license number 17372, as authorized under 59 Okla. Stat. §503.1 and 75 Okla. Stat. §314. In support of this application, the State submits the following:

1. The Board is a duly authorized agency of the State of Oklahoma empowered to license and oversee the activities of physicians and surgeons in the State of Oklahoma pursuant to 59 Okla. Stat. §480 *et seq.* (the "Act"). Under Section 503.1 of the Act, the Secretary of the Board may determine that "an emergency exists for which the immediate suspension of a license is imperative for the public health, safety and welfare."

2. Defendant, Stephen Lester Greer, M.D., holds Oklahoma license no. 17372, and is authorized to practice as a physician and surgeon.

3. On November 10, 2004, Defendant submitted to a Multidisciplinary Assessment at Rush Behavioral Health Center based upon allegations of sexual misconduct set forth in a Complaint filed by the State of Oklahoma. Defendant's Complaint had previously been set to be heard by the Board on November 4, 2004, but was continued based upon Defendant's agreement to submit to the assessment at Rush.

4. The Rush Multidisciplinary Assessment team concluded as follows:

In light of the above matters, we are of the opinion, to a reasonable degree of medical and psychiatric certainty, Dr. Greer is not currently appropriate to


practice medicine with requisite competency, safety, and skill. Within one week to ten days of receiving these recommendations, Dr. Greer would be expected to have arranged for coverage of his patients and closed his psychiatric practice. He would also be expected to then immediately enter a residential program for health professionals who have engaged in sexual misconduct. Our impressions have been shared with Dr. Greer.

5. The State is basing its application for emergency upon the recommendation of Rush, and the fact that as of November 30, 2004, nineteen (19) days after his discharge from Rush, he is still practicing and has not closed his practice, despite receiving the Rush recommendations at the time of his discharge.

6. Defendant's failure to abide by the recommendations of Rush, his failure to close his practice, his failure to arrange for coverage of his patients, and his failure to immediately enter residential treatment for sexual misconduct, and Rush's conclusion that Defendant is not currently appropriate to practice medicine with requisite competency, safety and skill justify an emergency suspension hearing to protect the public health, safety and welfare.

WHEREFORE, the State respectfully requests that an emergency be declared, that an emergency suspension hearing be conducted by the Secretary and that the Secretary suspend Defendant's license until a hearing before the Board *en banc*.



FINAL ORDER OF SUSPENSION

Elizabeth A. Scott, Assistant Attorney General, appeared for the plaintiff and defendant appeared in person and through counsel, Stephen Peterson.

The Board *en banc* after hearing arguments of counsel, reviewing the pleadings filed, and being fully advised in the premises, found that there is clear and convincing evidence to support the following Findings of Fact, Conclusions of Law and Orders:

8. Defendant is guilty of unprofessional conduct in that he:

- A. Abused the physician's position of trust by coercion, manipulation or fraudulent representation in the doctor-patient relationship in violation of OAC 435:10-7-4(44).
- B. Failed to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient in violation of 59 O.S. §509 (19).
- C. Violated any state or federal law or regulation relating to controlled substances in violation of OAC 435:10-7-4(27).

Conclusions of Law

1. The Board has jurisdiction and authority over the Defendant and subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act (the "Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare.


2. Defendant is guilty of unprofessional conduct in that he:
 - A. Abused the physician's position of trust by coercion, manipulation or fraudulent representation in the doctor-patient relationship in violation of OAC 435:10-7-4(44).
 - B. Failed to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient in violation of 59 O.S. §509 (19).
 - C. Violated any state or federal law or regulation relating to controlled substances in violation of OAC 435:10-7-4(27).
3. The Board further found that the Defendant's license should be suspended based upon any or all of the violations of the unprofessional conduct provisions of 59 O.S. §509 (19) and OAC Title 435:10-7-4 (27) and (44).

Order

IT IS THEREFORE ORDERED by the Oklahoma State Board of Medical Licensure and Supervision as follows:


1. The license of Defendant, Stephen Lester Greer, M.D., Oklahoma license no. 17372, is hereby **SUSPENDED INDEFINITELY** beginning January 27, 2005 and continuing until he completes treatment from a Board approved psychiatrist with expertise in treating psychiatrists with boundary issues and provides a report from this psychiatrist to the Board that he is safe to practice, at which time Defendant may appear before the Board to seek reinstatement of his license.
2. Promptly upon receipt of an invoice, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and investigation costs.
3. Defendant's suspended license shall not be reinstated unless Defendant has reimbursed the Board for all taxed costs.

The Board *en banc* after hearing arguments of counsel, reviewing the pleadings filed, and being fully advised in the premises, found that there is clear and convincing evidence to support the following Revised Findings of Fact, Conclusions of Law and Orders:

Defendant engaged in these acts at the same time that he was maintaining a doctor-patient relationship and prescribing controlled dangerous substances to this patient.

6. During the time that Defendant was treating Patient DHW and was committing non-sexual boundary violations with Patient DHW, Defendant paid for a motel for three (3) weeks for Patient DHW and her son. During this time, he frequently visited Patient DHW at the motel.

7. Beginning on or around May 29, 2003 and continuing through February 4, 2004, Defendant prescribed controlled dangerous substances to Patient DHW. A review of Defendant's chart on this patient reveals that Defendant failed to keep any records of the prescribing or ordering of these controlled dangerous substances after October 15, 2003.

8. Defendant is guilty of unprofessional conduct in that he:

- A. Abused the physician's position of trust by coercion, manipulation or fraudulent representation in the doctor-patient relationship in violation of OAC 435:10-7-4(44).
- B. Failed to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient in violation of 59 O.S. §509 (19).
- C. Violated any state or federal law or regulation relating to controlled substances in violation of OAC 435:10-7-4(27).

Conclusions of Law

- 1 The Board has jurisdiction and authority over the Defendant and

subject matter herein pursuant to the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act (the "Act") and its applicable regulations. The Board is authorized to enforce the Act as necessary to protect the public health, safety and welfare.

2. Defendant is guilty of unprofessional conduct in that he:

 - B. Failed to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient in violation of 59 O.S. §509 (19).
 - C. Violated any state or federal law or regulation relating to controlled substances in violation of OAC 435:10-7-4(27).


3. The Board further found that the Defendant's license should be suspended based upon any or all of the violations of the unprofessional conduct provisions of 59 O.S. §509 (19) and OAC Title 435:10-7-4 (27) and (44).

Order

2. Promptly upon receipt of an invoice, Defendant shall pay all costs of this action authorized by law, including without limitation, legal fees and investigation costs.
3. Defendant's suspended license shall not be reinstated unless Defendant has reimbursed the Board for all taxed costs.



**ORDER GRANTING REINSTATEMENT OF
LICENSE UNDER TERMS OF PROBATION**

This matter came on for hearing before the Oklahoma State Board of Medical Licensure and Supervision on May 5, 2005, at the Board office, 5104 North Francis, Suite C, Oklahoma City, Oklahoma 73118, pursuant to notice given as required by law and rules of the Board.

Defendant, Stephen Lester Greer, M.D., appeared in person and through counsel, Steve Peterson.

Elizabeth A. Scott, Assistant Attorney General, appeared on behalf of the State of Oklahoma, ex rel. the Oklahoma State Board of Medical Licensure and Supervision.

The Board *en banc* heard testimony, reviewed the exhibits presented, and being fully apprised of the premises, entered the following Findings of Fact, Conclusions of Law, and Orders:

Findings of Fact

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. On January 27, 2005, after hearing before the Board *en banc*, the Board entered a Final Order of Suspension whereby it suspended Defendant's license until he completed treatment from a Board approved psychiatrist with expertise in treating psychiatrists with boundary issues and provided a report from this psychiatrist to the Board that he is safe to practice, at which time Defendant could appear before the Board to seek reinstatement of his license.

3 Defendant is now seeking reinstatement of his Oklahoma medical license no. 17372.

CONCLUSIONS OF LAW

- 1 The Board has jurisdiction to reinstate the license of a physician pursuant to 59 O.S. §508.1.
2. The Board may impose practice parameters and other restrictions as necessary to protect the health, safety and welfare of the public under 59 O.S. §480 *et seq.*

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Defendant's medical license shall be reinstated under the following terms and conditions of **PROBATION**, which shall continue for a minimum period of one (1) year from the date of reinstatement under the following terms and conditions:

A. Defendant will conduct his practice in compliance with the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act as interpreted by the Oklahoma State Board of Medical Licensure and Supervision. Any question of interpretation regarding said Act shall be submitted in writing to the Board and no action based on the subject of the question will be taken by Defendant until clarification of interpretation is received by Defendant from the Oklahoma State Board of Medical Licensure and Supervision.

B. Upon request of the Board Secretary, Defendant will request all hospitals in which he anticipates practicing to furnish to the Board Secretary of the Oklahoma State Board of Medical Licensure and Supervision a written statement regarding monitoring of his practice while performing services in or to that hospital.

C. Defendant will furnish to each and every state in which he holds licensure or applies for licensure and hospitals, clinics or other institutions in which he holds or anticipates holding any form of staff privilege or employment, a copy of the Board Order stipulating sanctions imposed by the Oklahoma State Board of

Medical Licensure and Supervision.

- D. Defendant shall have a chaperone, who shall be an intern or other licensed health care provider, with him at any time that he is treating a female patient.
- E. Defendant shall comply with all recommendations of the Meier Clinics, including, but not limited to, installation of windows in all office doors and new policies regarding home visits and policies regarding office staff.
- F. Defendant will execute such releases of medical and psychiatric records during the entire term of probation as necessary for use by the Compliance Consultant or other Board designee to obtain copies of medical records and authorize the Compliance Consultant or other Board designee to discuss Defendant's case with Defendant's treating physicians and/or any physicians holding Defendant's records.
- G. Defendant shall promptly notify the Board of any citation or arrest for traffic or for criminal offenses involving substance abuse.
- H. Defendant will keep the Oklahoma State Board of Medical Licensure and Supervision informed of his current address.
- I. Defendant will keep current payment of all assessments by the Oklahoma State Board of Medical Licensure and Supervision for prosecution, investigation and monitoring of his case, including but not limited to a \$100.00 per month probation monitoring fee.
- J. Until such time as all indebtedness to the Oklahoma State Board of Medical Licensure and Supervision has been satisfied, Defendant will reaffirm said indebtedness in any and all bankruptcy proceedings.
- K. Defendant shall make himself available for one or more personal appearances before the Board or its designee upon request.
- L. Defendant shall submit any required reports and forms on a timely and prompt basis to the Compliance Coordinator or designee.
- M Failure to meet any of the terms of this Board Order will

constitute cause for the Board to initiate additional proceedings to suspend, revoke or modify Defendant's license after due notice and hearing.

N. Defendant will not supervise allied health professionals that require surveillance of a licensed physician.

O. Defendant will continue psychotherapy with a therapist to be approved in advance by the Board Secretary. Defendant shall submit monthly reports of his treatment from his therapist to the Board Secretary or his designee for his review until he is discharged by said therapist and the Board. Defendant's treatment shall consist of not less than one (1) visit per week. Defendant shall authorize in writing the release of any and all records of this treatment to the Board or its designee.

P. Defendant will continue treatment with a psychiatrist to be approved in advance by the Board Secretary. Defendant shall submit monthly reports of his treatment from his psychiatrist to the Board Secretary or his designee for his review until he is discharged by said psychiatrist and the Board. Defendant's treatment shall consist of not less than one (1) visit per week and may consist of telephone or personal consultation. Defendant shall authorize in writing the release of any and all records of this treatment to the Board or its designee.


Q. At the end of one (1) year, Defendant may appear before the Board to seek modification of the terms of his probation.

2. During the period of probation, failure to meet any of the terms of probation will constitute cause for the Board to initiate additional proceedings to suspend or revoke Defendant's license, after due notice and hearing.

3. Defendant's suspension will be lifted, and his license will be reinstated only upon payment in full of all costs and expenses incurred by the State of Oklahoma.

4. A copy of this written order shall be sent to Defendant as soon as it is processed.



ORDER TERMINATING PROBATION

This matter came on for hearing before the Oklahoma Board of Medical Licensure and Supervision on July 20, 2006, at the Board office, 5104 N. Francis, Suite C, Oklahoma City, Oklahoma, pursuant to notice given as required by law and rules of the Board.

Applicant, Stephen Lester Greer, M.D., holding Oklahoma medical license no. 17372, appeared in person and pro se.

The Board sitting *en banc* after hearing testimony, reviewing the request and other materials presented, and being fully apprised of the premises, made the following Findings of Fact, Conclusions of Law and Orders:

FINDINGS OF FACT

1. The Board *en banc* has jurisdiction over the subject matter herein, and notice has been given in all respects as required by law and the rules of the Board.

2. Dr. Greer currently holds medical license no. 17372 under a one (1) year minimum term of probation that commenced on or around May 5, 2005.

3. Dr. Greer has requested that his probation be terminated so as to allow him to treat female patients without having an intern or other licensed health care provider present during the treatment.

4. Dr. Greer has complied to date in all respects with the terms of probation, and the purposes of the probationary period have been accomplished. Dr. Greer has presented sufficient evidence to support the requested termination.

CONCLUSIONS OF LAW


1. The Board has jurisdiction to hear this matter pursuant to 59 O. S. § 480 *et seq.*
2. Dr. Greer has presented satisfactory evidence to justify termination of his probationary period. The purposes of the probationary period have been accomplished by Dr. Greer's compliance with the probationary terms. No useful purpose would be gained by having Dr. Greer continue on probation.

ORDER

IT IS THEREFORE ORDERED by the Board of Medical Licensure and Supervision as follows:

1. Dr. Greer's application to terminate probation is **GRANTED** and his probationary period is terminated effective July 20, 2006.
2. A copy of this written order should be sent to Dr. Greer as soon as it is processed.
