Dear Dr. Parker:

This letter is official notification that an informal conference of the Virginia Board of Medicine ("Board") will be held on Wednesday, April 23, 2003, at 9:30 a.m., at the Williamsburg Marriott, 50 Kingsmill Road, Williamsburg, Virginia. The conference will be conducted pursuant to Sections 54.1-2919, 2.2-4019 and 2.2-4021 of the Code of Virginia (1950), as amended ("Code").

An Informal Conference Committee ("Committee"), composed of three members of the Board, will inquire into allegations that you may have violated certain laws governing the practice of osteopathy in Virginia. Specifically, you may be in violation of Section 54.1-2915.A(4) and (3), as further defined in Section 54.1-2914.A(3), (5), (11) and (12), Section 54.1-3303 and Section 54.1-3408 of the Code (1950), as amended ("Code"), in that, on or about January 8, 2002, outside of a bona fide physician/patient relationship and with the intent to evade the law with respect to the sale and disposition of a controlled substance, you fraudulently prescribed Dexedrine, a Schedule II controlled substance, for a family member under a false or fictitious name. Further, between June 2000, and March 2002, you prescribed Schedule VI controlled substances including Tetracycline and Acyclovir on various occasions to the same family member.

The following actions may be taken by this Committee:

1. If a majority of the Committee is of the opinion that a suspension or revocation of your license may be justified, the Committee shall present to the Board in writing its findings, and the Board may proceed with a formal hearing.

- 2. The Committee may notify you in writing that you are fully exonerated of any charge that might affect your right to practice osteopathy in Virginia.
  - 3. The Committee may reprimand or censure you.
- 4. The Committee may impose a monetary penalty pursuant to Section 54.1-2401 of the Code.
- . 5. The Committee may place you on probation for such time as it may designate and direct that during such period you furnish the Committee or its chairman, at such intervals as the Committee may direct, evidence that you are not practicing in violation of the provisions of Chapter 29, Title 54.1 of the Code, which governs the practice of osteopathy in Virginia.

In lieu of proceeding to the above informal conference, the Board hereby offers to enter into the enclosed Consent Order with you. Please review this document and should you consent to its terms, signed the Consent Order before a notary public. In order for it to become effective, you must return this original Consent Order, bearing your witnessed signature, to the Board office by 12 noon on March 24, 2003. You will receive a certified copy shortly thereafter. Should the Board not receive this Consent Order from you by 12:00 noon on March 24, 2003, the Board will proceed with the informal conference as described herein.

You have the right to information, which will be relied upon by the Committee in making a decision. Therefore, I enclose a copy of the documents, which will be distributed to the members of the Committee, and will be considered by the Committee when discussing the allegations with you and when deliberating upon your case. These documents are enclosed only with the original notice sent by certified mail, and must be claimed at the post office. You may be represented by an attorney at the informal conference. The enclosed materials have also been provided to your attorney, Robert F. McDonnell, Esquire.

Absent good cause shown to support a request for a continuance, the informal conference will be held on <u>April 23, 2003</u>. A request to continue this proceeding must state in detail the reason for the request and must establish good cause. Such request must be made in writing to me at the address listed on this letter and must be received by 12 noon on March 26, 2003. Only one such motion will be considered. Absent exigent circumstances, such as personal or family illness, a request for a continuance after March 26, 2003, will not be considered.

To facilitate this proceeding, you must submit eight (8) copies of any documents you wish for the Committee to consider to Reneé S. Dixson, Discipline Case Manager, Virginia Board of Medicine, 6603 West Broad Street, 5th Floor, Richmond, Virginia 23230-1717, by 12 noon on April 2, 2003. Your documents may not be submitted by facsimile or e-mail. Should

you or Senior Adjudication Analyst Whitney Lou wish to submit any documents for the Committee's consideration <u>after</u> April 2, 2003, such ocuments shall be considered <u>only</u> upon a ruling by the Chair of the informal conference committee that good cause has been shown for late submission.

**CONSENT ORDER** 

By letter dated February 25, 2003, the Virginia Board of Medicine ("Board") noticed Dr.

Parker for an informal conference to inquire into allegations that he may have violated certain

laws governing the practice of osteopathic medicine in the Commonwealth of Virginia.

In lieu of proceeding to this informal conference, the Board and Dr. Parker, as

evidenced by their signatures affixed below, agree to enter into this Consent Order affecting

the license of Dr. Parker to practice osteopathic medicine in Virginia.

FINDINGS OF FACT

The Informal Conference Committee of the Board makes the following findings in this

matter:

1. Dr. Parker was issued license number 0102-026059 by the Board to practice

osteopathic medicine in the Commonwealth of Virginia on June 2, 1975. Said license will

expire on February 29, 2004, unless renewed or otherwise restricted.

2. On or about January 8, 2002, outside of a bona-fide physician/patient

relationship, Dr. Parker prescribed Dexedrine, a Schedule II controlled substance, to an

individual using a false or fictitious name. Dr. Parker wrote the prescription, at the

individual's request, for the purpose of protecting the confidentiality of the individual.

3. Medical records from another physician indicate that Dexedrine had been

lawfully prescribed for said individual for a bona-fide medical and therapeutic purpose.

### **CONCLUSIONS OF LAW**

Based on the foregoing Findings of Fact, the Committee concludes that Dr. Parker is in violation of Section 54.1-2915.A(3), as further defined in Section 54.1-2914.A(3) and (12), and Section 54.1-3303 of the Code (1950).

#### CONSENT

- I, Charles Parker, D.O., by affixing my signature hereto, acknowledge that:
- I have been advised specifically to seek the advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me, except pursuant to the Virginia Administrative Process Act, § 2.2-4000 A et seq. of the Code of Virginia;
  - 3. I have the following rights, among others:
    - a. the right to a formal fact-finding hearing before the Board;
    - b. the right to representation by counsel; and
    - c. the right to cross-examine witnesses against me.
  - 4. I waive all rights to a formal hearing;
  - 5. I neither admit nor deny the truth of the above Findings of Fact;
- 6. I shall maintain a course of conduct in my practice of osteopathic medicine commensurate with the requirements of Title 54.1, Chapter 29 of the Code, and all laws of the Commonwealth; and

7. I consent to the following Order affecting my license to practice osteopathic medicine in the Commonwealth of Virginia.

#### **ORDER**

WHEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, and with the consent of the licensee, it is hereby ORDERED that Dr. Parker be issued a REPRIMAND and that a MONETARY PENALTY of one thousand dollars (\$1,000.00) be imposed, to be paid within thirty (30) days of entry of this Order. Further, within six (6) months of entry of this Consent Order, Dr. Parker shall complete sixteen (16) hours of continuing medical education relating to the proper prescribing of controlled substances. Said courses shall be approved in advance of registration by the Executive Director of the Board. Within twenty-one (21) days of completion of said continuing education, Dr. Parker shall submit a certificate or other evidence, satisfactory to the Board, of completion of the course.

Upon receipt of evidence that Dr. Parker has complied with the requirements of this Order, this case shall be closed without further proceedings. In the event Dr. Parker fails to comply with the requirements of this Order, in the Board's discretion, he may be noticed to appear before an informal conference committee of the Board.

Pursuant to Section 2.2-4023 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.
