CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Medicine ("Board") and Claudia Yasmin Rodriguez Galvis, M.D., as

evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the

following Consent Order affecting Dr. Rodriguez Galvis's license to practice medicine and surgery in the

Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Claudia Yasmin Rodrigucz Galvis, M.D., was issued License Number 0101-258015 to

practice medicine and surgery on April 7, 2015, which is scheduled to expire on July 31, 2020.

2. Dr. Rodriguez Galvis violated Virginia Code § 54.1-2915(A)(5) based on Final Orders by

Boards of Medicine in two states, in that:

a. By Final Order dated February 22, 2019, the State of Florida Board of Medicine

adopted a Settlement Agreement wherein it issued a Letter of Concern and imposed terms and conditions

upon Dr. Rodriguez Galvis' license, to include: an administrative fine, reimbursement of costs incurred,

and completion of continuing education in treating psychiatric conditions and in risk management. This

action was based on findings related to her prescribing an excessive dose of Seroquel for a psychiatric

patient.

b. By Final Order date July 24, 2019, the State of Michigan Board of Medicine

reprimanded Dr. Rodriguez Galvis and issued her a fine. This action was based on Dr. Rodriguez Galvis'

failure to notify the Michigan Bureau of Professional Licensing of the action taken by the Florida Board,

described above, within thirty (30) days of the date of the action, and her failure to respond to Michigan's Administrative Complaint related to the Florida action.

CONSENT

Claudia Yasmin Rodriguez Galvis, M.D., by affixing their signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal factfinding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - 4. I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my license to practice medicine and surgery in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Medicine hereby ORDERS as follows:

1. Claudia Yasmin Rodriguez Galvis, M.D., is REPRIMANDED.

2. Dr. Rodriguez Galvis shall fully comply with the terms and conditions of the Florida

Final Order and shall advise this Board, in writing, of any change to the Order within ten (10) calendar

days of such change.

3. Upon receipt of evidence acceptable to the Board verifying that Dr. Rodriguez Galvis has

completed the terms and conditions of the Florida Final Order, the Board authorizes the Executive Director

to close this matter.

4. Any violation of the foregoing Terms and Conditions of this Order or any statute or

regulation governing the practice of medicine and surgery shall constitute grounds for further disciplinary

action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.
