#### **CONSENT ORDER**

#### JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Medicine ("Board") and Charles D. Moseley, M.D., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Dr. Moseley's license to practice medicine in the Commonwealth of Virginia.

#### FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Charles D. Moseley, M.D., was issued License Number 0101-019922 to practice medicine on June 30, 1969, which is scheduled to expire on October 31, 2022.

2. Charles D. Moseley, M.D., violated Virginia Code § 54.1-2915.A(3), (17) and (18); 54.1-3303 and 54.1-3408; and 18 VAC 85-21-60 of the Regulations Governing the Practice of Medicine, Osteopathic Medicine, Podiatry and Chiropractic, in his care and treatment of Patients A – F. Specifically: Dr. Moseley, a psychiatrist, failed to perform and/or document adequate physical examinations prior to issuing prescriptions for drugs of significant abuse potential, including alprazolam, hydrocodone and oxycodone for treatment of pain and/or anxiety in Patients A – F. Dr. Moseley failed to obtain reported treatment records from past providers, to coordinate care with current treatment providers, or to refer patients to appropriate specialists for pain management and/or substance abuse treatment. Dr. Moseley failed to respond appropriately to signs of potential drug-seeking behavior, or to utilize any measures to ensure that patients were compliant with his treatment regime, such as accessing the Prescription Monitoring Program, utilizing urine drug screens, pill counts, or narcotic pain management contracts. 3. In a letter to the Board investigator dated May 7, 2021, Dr. Moseley stated he planned to retire from the practice of medicine on June 11, 2021 after 52 years of practice as a psychiatrist.

#### CONSENT

Charles D. Moseley, M.D., by affixing his signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document and am represented by Katherine Skilling Larkin, Esq. and Joel McCray, Esq.;

2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;

3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;

4. I waive my right to an informal conference;

5. I neither admit nor deny the Findings of Fact and Conclusions of Law contained herein but waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my license to practice medicine in the Commonwealth of Virginia.

#### **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Medicine hereby ORDERS as follows:

1. The Board accepts the VOLUNTARY PERMANENT SURRENDER of the license of Charles D. Moseley, M.D., to practice medicine in the Commonwealth of Virginia.

2. Upon entry of this Consent Order, Dr. Moseley's license will be recorded as SURRENDERED and no longer current. Dr. Moseley will not be eligible for reinstatement of his license at any future date.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
