CONSENT ORDER

The Virginia Board of Medicine and Gary Walker Boggus, M.D., as evidenced by their signatures affixed below, agree to enter into this Consent Order affecting the license of Dr. Boggus to practice medicine and surgery in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

The Board makes the following findings of fact and conclusions of law in this matter:

1. Dr. Boggus was issued license number 0101-050420 by the Board to practice medicine and surgery in the Commonwealth of Virginia on February 1, 1994. Said license is currently active and will expire on December 31, 2008, unless renewed or otherwise acted upon.

2. Dr. Boggus violated Section 54.1-2915.A(18) and 18 VAC 85-20-26(C) of the Board of Medicine General Regulations, in that, on multiple occasions from approximately July 2005 to April 2006, he failed to properly manage patient records, failed to maintain timely, accurate, legible, and complete patient records for Individual A.

CONSENT

I, Gary Boggus, M.D., by affixing my signature hereto, acknowledge that:

1. I have been advised specifically to seek the advice of counsel prior to signing this document; and I am represented by Douglas E. Penner, Esq.

2. I am fully aware that without my consent, no legal action can be taken against me, except pursuant to the Virginia Administrative Process Act, § 2.2-4000.A et seq. of the Code;
3. I have the following rights, among others:
 - a. the right to an informal conference before the Board, and
 - b. the right to appear in person or by counsel, or other qualified representative before the agency.
4. I waive all rights to an informal conference;
5. I admit the truth of the above Findings of Fact and Conclusions of Law; and
6. I consent to the following Order affecting my license to practice medicine and surgery in the Commonwealth of Virginia.

ORDER

WHEREFORE, based on the foregoing Findings of Fact and Conclusions of Law, and with the consent of the licensee, it is hereby ORDERED that Gary W. Boggus, M.D., be, and hereby is, issued a REPRIMAND.

It is further ORDERED that, within thirty (30) days from entry of this Consent Order, Dr. Boggus shall provide the Board with a written statement certifying that he has read, and will comply with: (i) the laws governing the practice of medicine (Title 54.1, Chapter 29 of the Code); (ii) the Regulations Governing the Practice of Medicine, Osteopathic Medicine, Podiatry and Chiropractic (18 VAC 85-20-10 *et seq.*); Section 54.1-3303 of the Code; and (iv) the Drug Control Act (Title 54.1, Chapter of the Code).


Upon receipt of evidence that Dr. Boggus has complied with the requirements of the Consent Order, the Committee authorizes the Executive Director of the Board to close this matter without further proceedings.

Dr. Boggus shall maintain a course of conduct in his practice of medicine commensurate with the requirements of Title 54.1, Chapter 29 of the Code and all laws of the Commonwealth.

Violation of this Consent Order may constitute grounds for the suspension or revocation of Dr. Boggus' license. In the event Dr. Boggus violates the terms of this Consent Order, an administrative proceeding will be convened to determine whether his license should be suspended or revoked.




