I (OFC KING 844) WAS DISPATCHED TO 1340 LINCOLN RD #809 REF TO A CALL OF THE DOCTOR FROM MT SINAI HOSPITAL THAT HAD POSSIBLY ABUSED ONE OF HIS PATIENTS. UPON ARRIVAL I MET WITH THE V01 (A [REDACTED] S [REDACTED]) WHO ADVISED THAT ON 4-27-13 SHE WAS BAKER ACTED FOR AN ATTEMPTED SUICIDE ATTEMPT AND TAKEN TO MT SINAI HOSPITAL IN MIAMI BEACH. V01 STATED THAT SHE SLEPT FOR APPROXIMATELY A DAY TO A DAY AND HALF WHILE RECOVERING FROM THE MEDICATION THAT SHE HAD TAKEN (BENADRYL) AND THAT ON TUESDAY 4-30-13 BETWEEN THE HOURS OF 7:00PM AND 9:00PM THE SUBJECT (POP), THE PSYCHIATRIST TREATING HER, CAME BY HER ROOM WHILE CONDUCTING HIS ROUNDS. V01 SAYS THAT THE OTHER PATIENT IN THE ROOM HAD ALREADY BEEN DISCHARGED AND THAT IT WAS ONLY V01 AND S01 IN THE ROOM. V01 ADVISED THAT S01 BEGAN ASKING V01 ABOUT TANTRIC SEX, WHICH SHE STATES MADE HER VERY UNCOMFORTABLE. SHE THEN TOLD S01 THAT TANTRIC SEX IS NOT WHAT SHE DOES AND ATTEMPTED TO AVOID THE CONVERSATION. V01 STATES THAT S01 TOLD HER THAT SHE HAS A "HAUNTING SMILE" AND THAT HE "CANT STOP THINKING OF YOU". V01 FURTHER STATES THAT S01 FORCEFULLY GRABBED V01 BY THE FACE (CHIN AREA) AND BEGAN TO KISS HER, FORCING HIS TONGUE INTO V01'S MOUTH. V01 ATTEMPTED TO PULL AWAY BUT WAS UNABLE TO PULL AWAY DUE TO THE FORCE THAT S01 WAS USING TO HOLD HER FACE. V01 FINALLY PULLED AWAY AND TOLD S01 "PLEASE DON'T" AND THAT PEOPLE COULD BE WATCHING. V01 SAYS THAT S01 BECAME QUITE AFTER THAT AND SOON LEFT THE ROOM.

V01 SAYS THAT SHE WAS AFRAID TO ADVISE HOSPITAL STAFF AT THE TIME, IN FEAR THAT S01 WOULD PROLONG HER STAY AND THAT SHE KNEW IT WOULD ONLY BE HER WORD AGAINST HIS. V01 WAS DISCHARGED FROM THE HOSPITAL ON 5-1-13 AND CALLED HER BROTHER TO ADVISE HIM WHAT HAD HAPPENED. AFTER SPEAKING TO HER BROTHER, V01 DECIDED TO CALL POLICE AND FILE A REPORT. V01 BEGAN TELLING ME THAT S01 HAD MADE SEVERAL PHONE CALLS TO HER CELL PHONE (3 CALLS 3:09PM, 8:08PM, AND 9:32PM) AND AFTER THE LAST CALL S01 ASKED HER TO CALL HIM BACK. AT 10:14PM V01 CALLED S01 BACK, WHILE I WAS PRESENT AND PLACING THE PHONE ON SPEAKER, AT WHICH TIME S01 STATED THAT HE WOULD CALL HER BACK IN A FEW MINUTES. AT 10:18PM S01 CALLED V01 BACK (FROM PHONE NUMBER 954-347-2161) AND V01 ANSWERED AND ONCE AGAIN PLACED THE PHONE ON SPEAKER FOR ME TO HEAR. V01 AND S01 HAD AN APPROXIMATELY 18 MINUTE CONVERSATION IN WHICH S01 ASKED V01 NOT TO DISCUSS ANY OF THIS WITH ANYONE, AND THAT HE LOOKED AT HER LIKE A FRIEND. S01 FURTHER STATED, WHILE I WAS LISTENING, THAT HE LIKED HER ANATOMY AND THAT HE LIKED HER TONGUE VERY MUCH. V01 REPEATED THESE COMMENTS TO S01 AT WHICH TIME HE REPEATED THAT HE LIKED HER ANATOMY AND HE LIKED HER TONGUE. S01 ALSO STATED THAT HE WANTED TO SEE V01 AND THAT POSSIBLY HE COULD COME TO HER APARTMENT. V01 CONTINUED TO REPEAT THE STATEMENTS TO S01 AND HE CONTINUED TO SAY THEM TO HER AGAIN. V01 ENDED THE CONVERSATION AT WHICH TIME I CONTACTED DET ERBEN # 684 AND ADVISED HIM OF THE SITUATION. DET ERBEN HAD V01 RESPOND TO THE MBPD STATION WHERE HE TOOK OVER THE INVESTIGATION.
