ADVOCATE PROGRAM.

It is further ordered that you shall comply with the following conditions of probation:

- (1) You will report in person within 72 hours or within 72 hours of your release from confinement to the Advocate Program Inc. You will report monthly thereafter. Failure to report due to lack of funds is not a legally valid excuse for failing to report to the Advocate Program.
- (2) You will not change your residence, employment, telephone or leave the county of your residence without procuring the consent of your Probation Supervisor.
- (3) You will neither possess or carry any weapon or firearm.
- (4) An arrest during the period of probation shall be considered a violation of probation; a conviction in a court of law shall not be necessary to constitute a violation.
- (5) You will not use intoxicants to excess: nor will you visit places where intoxicants, drugs or other dangerous substances are unlawfully sold, dispensed or used.
- (6) You will work diligently at a lawful occupation and support any dependents to the best of your ability.
- (7) You will make payment of the \$55.00 per month fee for the cost of your supervision while on Probation.
- (8) You will enter and complete the Advocate Program including any special conditions listed below:

All conditions of probation must be completed at least 30 days prior to the end of your probationary period unless otherwise specified herein.

YOU ARE HEREBY PLACED ON NOTICE THAT THE COURT may at any time rescind or modify any of the conditions of your probation, or may extend the period of probation as authorized by law or may discharge you from further supervision. If you violate any of the conditions of your probation, you may be arrested and the court may revoke your probation and impose any sentence which it might have imposed before placing you on probation.
